Dear Ms. Porter:

The amendment referred to above, submitted in connection with registration under section 3 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) is acceptable. As requested in your amendment dated November 21, 2011, the terms and conditions of your registration are amended as follows:

- 1. Amvac must submit to the OPP Product Manager for PCNB an impurity profile for the congeners of the impurities listed in the amended CSF for each finished, ready to label manufacturing lot of the technical product before the first release of that lot for sale or distribution. OPP will reevaluate the need for these submissions of impurity profiles at regular intervals beginning six months after the time of the first submission. In making these reevaluations of whether to remove the condition requiring the submission of impurity profiles, OPP will consider, among other factors, the following: (1) the number of lots evaluated at six months; (2) the levels of the impurities in those lots; (3) the variability in levels of the impurities within and across the lots; and (4) the extent to which the lots have to be blended in order to stay below the required limit on the CSF. When, and if, OPP determines that the condition can be removed from this registration, Amvac recognizes that it must continue collecting and maintaining information to document compliance with the certified limits for impurities included in the amended CSF for this product after this condition of registration has been satisfied, and will make such information available to EPA upon request.
- 2. Amvac will not market for reformulation into any registered product labeled for any end use other than the following: golf course turf (tees/greens/fairways), sod farms, industrial parks, professional and college athletic fields (liquid and granular); broccoli (including Chinese), Brussels sprouts, cabbage (including Chinese), cauliflower (liquid and granular); collards, kale, and mustard greens (liquid and granular); peppers (liquid and granular); beans (snap, succulent, and dry) (liquid and granular); peanuts (liquid and granular); garlic (liquid); tomatoes (liquid), cotton (liquid and granular); potato (liquid and granular); southern magnolia trees (liquid); southern pine seed or seedlings (liquid); and vegetable bedding plants (liquid and granular).

- 3. EPA has yet to make decisions for the remaining PCNB end uses; therefore, the removal of the condition of registration in paragraph 2 is predicated on either a decision by EPA to allow the remaining uses to be marketed, or a request by Amvac to delete each of the remaining uses.
- 4. Amvac may only sell or distribute with labeling bearing the following labeling statements: "This product may only be reformulated into end-use products that do not bear directions for use for any use other than for golf course turf (tees/greens/fairways), sod farms, industrial parks, professional and college athletic fields (liquid and granular); broccoli (including Chinese), Brussels sprouts, cabbage (including Chinese), cauliflower (liquid and granular); collards, kale, and mustard greens (liquid and granular); peppers (liquid and granular); beans (snap, succulent, and dry) (liquid and granular); peanuts (liquid and granular); garlic (liquid); tomatoes (liquid), cotton (liquid and granular); potato (liquid and granular); ornamental bulb soak (liquid); woody ornamentals (liquid and granular); southern magnolia trees (liquid); southern pine seed or seedlings (liquid); and vegetable bedding plants (liquid and granular); and this product may only be reformulated into a registered pesticide product for which the registration was either initially granted or amended by EPA after November 21, 2011.
- 5. Amvac will submit a subsequent amended "master" label along with any additional use deletion requests submitted after EPA makes a determination concerning those retained uses of this product that are not allowed by the condition of registration governing the accepted master label appended to this letter.
- 6. Amvac will submit one (1) copy of the final printed label before the product is released for shipment.
