POTATOES

STEM CANKER & BLACK SCURF (*Rhizoctonia solani*)

For Increased Control of Stem Canker and Black Scurf Caused by *Rhizoctonia solani* When Used in Conjunction with Potato Seed Treatments. As An Over-All Broadcast Treatment: Apply 100 lbs. of PCNB 10% Granules per acre over the soil surface prior to planting and thoroughly disc to a depth of 4 to 6 inches, crossdiscing if necessary. **As an In-Furrow Treatment:** Apply in-furrow as an 8.5" band at a rate of 1.65 lbs. of PCNB 10% Granules per 1,000 linear feet of row. This is equivalent to an application rate of 25 lbs. per treated acre assuming a 34" row spacing. Direct the product into the furrow over the seed, and cover as part of the hilling operation during planting. It is best to apply when the soil is slightly moist. Do not harvest within 45 days of application.

All applicable directions, restrictions and precautions on the EPA-registered label for PCNB 10% Granules are to be followed.
