#### BEANS

Root and Stem Rot (Rhizoctonia solani) - APPLY AS AN IN-FURROW SOIL TREATMENT. Apply 10 to 15 lbs. per 14,500 linear feet of row for Bush Beans or per 8,340 square feet of row for Pole Beans. Apply over the seed at planting time in the furrow and immediately cover with soil utilizing appropriate application equipment. Do not feed treated vines to livestock.

#### CRUCIFERS - CABBAGE, CAULIFLOWER, BRUSSELS SPROUTS AND BROCCOLI

Clubroot (Plasmodiophora brassicae): APPLY AS A PRE-TRANSPLANTING ROW TREATMENT - Apply 200 lbs. per 13,100 feet of row for Cabbage, Broccoli and Brussels Sprouts or 10,900 linear feet of row for Cauliflower in a 12 to 15-inch band. #### For Brown Patch (Rhizoctonia solani)

Southem Grasses - For SL Augustine, Bermuda, etc. and Dichondra - Apply 7½ lbs. per 1,000 square feet in the fall or the spring at the first sign of infection. Lightly sprinkle the area to wash the granules to soil level. An additional application in 3 to 4 weeks may be needed for continued control if heavy rainfall or flooding occurs after this treatment.

Northern Grasses - For Bluegrass, Fescue, Rye, Bent, etc. Apply 2 to 2½ lbs. per 1,000 square feet when disease first appears and repeat at 7 to 10-day intervals during warm, damp weather. Lightly sprinkle the area to wash granules to soil level.
