**PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

Wear GOGGLES or FACE SHIELD when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and separately launder clothing before reuse.

**PRECAUTIONS FOR AGRICULTURAL USES**

Mixers/loaders when mixing and loading this product must wear a LONG SLEEVED SHIRT and LONG PANTS or a COVERALL that covers all parts of the body except the head, hands and feet. Wear CHEMICAL RESISTANT GLOVES, GOGGLES or a FACE SHIELD and CHEMICALLY RESISTANT APRON.

Fieldworkers and harvesters must wear CHEMICAL RESISTANT GLOVES. Leather or fabric gloves are not acceptable. See re-entry statement.

**AFTER WORK:** Take off all clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after each use. Personal clothing worn during use must be laundered separately from household articles. Clothing and protective equipment heavily contaminated or drenched with Captan must be destroyed according to state and local regulations.

A DUST MASK must be worn when mixing and loading this product.

During application only, from a tractor with a completely enclosed cab or from an aircraft with an enclosed cockpit a long sleeved shirt and long legged pants must be worn. Chemically resistant gloves must be available in the cab or cockpit and worn while exiting.

**APPLES:** For control of Scab, Cedar Rust, Quince Rust, and Powder Mildew on apples use at the rate of 50 lbs. dust per acre. Dust thoroughly to give complete coverage of leaves and blooms. Use in place of bloom spray during extremely wet weather when spraying is impossible. Do not use an insecticide with this application. Do not use within 7 days of harvest.

Do not use treated apples in the manufacture of apple pomace for use in livestock feeds. Do not graze cover crops in treated orchards. Russetting may occur on Golden Delicious, Grimes Golden and Rhode Island Greening varieties. Sulfur may burn foliage when temperatures are excessively high (above 92°F.) Do not use sulfur on apple foliage within 7 to 10 days of an oil spray.
