
You have incorrect wording in the second-to-last sentence in the first pararaph in the Agricultural Use Requirements box on your proposed label. The sentence must be as follows: "It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), notification to workers and restricted-entry interval."

The correct restricted entry interval (REI) for this product is 24 hours. Your REI statement must read: "Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 24 hours." The exact location is shown in Section F on Part 2 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

The bodywear requirement for early entry in the Agricultural Use Requirements box on your proposed labeling is missing or incorrect. Remove the incorrect requirement (if any) and add "Coveralls".
