DIRECTIONS: For transplanting in general mix a solution of <u>one teaspoonful of ALCO Vitamin B-1 Hormone</u> Concentrate in one gallon of water. Thoroughly saturate the soil around the plant with the solution.

FOR USE ON CUTTINGS, POTTED PLANTS, TREES, SHRUBS, FLOWERS OR HOUSE PLANTS

ALCO Vitamin B-1 Hormone Concentrate should be used at the same dilution rate (1 tsp. per gallon water) applied at weekly intervals until the plants become established.
