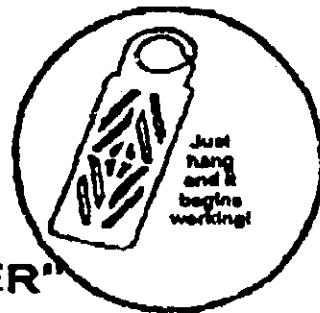

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Remove pre-assembled ALCO NO-PEST STRIP from sealed bag when ready to use. Hang in desired location away from windows and out of reach of children and pets. Do not use where unwrapped food is stored or allow the strip to come into contact with food or cooking utensils. Drafts, weather and other conditions may affect the performance, but treatment usually last for (4) months. Record the date of installation and replace with a new, fresh, full strength strip at the end of four (4) months or when effectiveness diminishes.

Assembly instructions for pre-assembled strip.

1. Gently squeeze edges of holder to open ends of unit.

2. Press in bottom locking tabs to prevent strip from sliding out of holder.

3. Without damaging the strip inside, carefully cut open the envelope with scissors. Slide strip into the holder at the top.

4. Press in top locking tabs to secure strip inside holder.

5. To hang, attach metal hook through hole of unit.

How much space will one strip treat?

| Size | Treats | Space Treated |
|--------|-----------------|------------------------|
| 10.5 g | 50-100 cu.ft. | 8'x4'x3'=96 cu.ft. |
| 21 g | 100-200 cu.ft. | 8'x8'x3'=192 cu.ft. |
| 80 g | 900-1200 cu.ft. | 12'x12'x8'=1152 cu.ft. |

Always use the appropriate size and number of ALCO NO-PEST STRIPS for the space being treated. If more than one is required distribute them over the space equally.

Homes, Cabins, Garages, Motels
Use as a Fly Killer

ALCO NO-PEST STRIP kills flies, gnats, mosquitoes, moths, silverfish, cockroaches, spiders, beetles and earwigs. ALCO NO-PEST STRIP also protects clothes against moths. When using around clothing, make sure strip does not contact clothes or fabric and that air can circulate around the strip. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Use as a Small Space Insect Killer

Kills flies and other household insects as listed all summer long. Remove from sealed bag and hang out of reach of children and pets and away from windows. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Closets, Wardrobes and Storage Spaces

Gives continuous protection against moths, silverfish, cockroaches and other insects as listed in closets, wardrobes and storage spaces. ALCO NO-PEST STRIP also protects clothes against moths and leaves no smell. Remove from sealed bag and hang on closet rail, ensuring that strip does not contact clothes or fabrics and that air can circulate around the strip. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used. Do not allow children or pets to sleep in closets, wardrobes or storage spaces while treatment is in progress.

Garbage Cans, Trash Dumpsters

To control flies in garbage cans and dumpsters attach ALCO NO-PEST STRIP inside can or dumpster. Keep lid on can or dumpster closed. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Animal Buildings

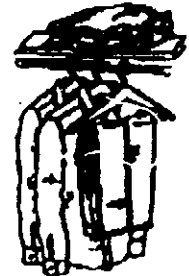
Controls flies, mosquitoes, and gnats in horse barns, calf parlors, hog parlors, stables, poultry houses, tack rooms and dog kennels. Do not contaminate food, water or foodstuffs. Do not contaminate milk or milking equipment. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Milk Rooms

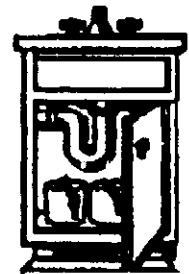
Controls flies, mosquitoes, and gnats in milkrooms and bulk storage rooms. DO NOT contaminate milk or milking equipment. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Agricultural Commodities

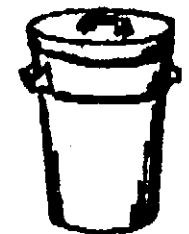
Bulk Storage of raw grains, corn, soybeans, cocoa beans, and peanuts. Controls Almond Moths, Cocoa Moth, Indian Meal Moth, and Mediterranean Flour Moths infesting non-perishable bulk stored raw agricultural commodities. Calculate cubic feet of air space above the commodity to determine the number of ALCO NO-PEST STRIPS required for treatment. Treat in early spring before moths begin to emerge. Replace strip when needed to prevent egg laying by moths.



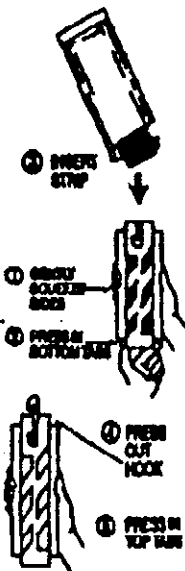

Catch Basins

To control mosquitoes breeding in catch basin, suspend one ALCO NO-PEST STRIP about ten (10) inches above water level. Usual control lasts 10 to 15 weeks.

Utility

To control Fire Ants, and Wasps, which commonly infest utility enclosures, cabinets, and junctions. Remove from sealed bag and hang so air can contact all sides of the ALCO NO-PEST STRIP. Use ALCO NO-PEST STRIP in enclosed areas for utility equipment such as communications equipment, electric, gas, water and cable television. Always refer to treatment chart to determine proper size and amount of ALCO NO-PEST STRIPS to be used.

Reptile Houses / Terrariums

For control of mites on reptiles: **In Reptile Houses:** Hang appropriate number of 80 gram strip per 1,000 cu.ft. for the space to be treated. Do not over treat. **In Terrariums:** Cover the top of an open terrarium having a minimum size of 10 cubic feet with a wire screen and place a 21 gram strip on the screen for 48 hours. Make sure that the reptiles can not touch or contact the NO-PEST STRIP.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not open or remove from package before ready to install. Store in cool, dry place. Do not reuse packaging. Wrap used packaging in several layers of newspaper and discard in trash collection.
