

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Remove pre-assembled ALCO NO-PEST STRIP from sealed bag when ready to use. Place (*Hang*) in desired location away from windows and out of reach of children and pets. (*To apply strips to vertical surfaces, use the enclosed stickers*). Drafts, weather and other conditions may affect the performance, but treatment usually lasts for four (4) months. (*One ___g strip will treat ___ cu. ft.*). Record the date of installation and replace with a new, fresh, full-strength strip at the end of four (4) months or when effectiveness diminishes. Do not use in the food/feed processing or food/feed manufacturing or food/feed service establishments. Animal Buildings

Controls flies, mosquitoes and gnats in horse barns, calf parlors, hog parlors, stables, poultry houses, tack rooms and dog kennels. Do not contaminate food, water or foodstuffs. DO NOT contaminate milk or milking equipment.

Milk Rooms

Controls flies, mosquitoes and gnats in milk rooms and bulk storage rooms. DO NOT contaminate milk or milking equipment.

Agricultural Commodities

Bulk storage of raw grains such as corn, soybeans, cocoa beans and peanuts. For control of stored product insects including Almond Moths, Cocoa Moths, Indian Meal Moths, and Mediterranean Flour Moths infesting non-perishable bulk-stored raw agricultural commodities. Calculate cubic feet of air space above the commodity to determine the number of strips required for treatment. Treat in early Spring before moths begin to emerge. Replace strip when needed to prevent egg laying by moths. Hang strips so as not to impede air circulation. When multiple strips are required, distribute them uniformly over the treated space.

Catch Basins

To control mosquitoes breeding in catch basin, suspend one (80) 65 g strip about ten inches above water level. Usual control lasts 10 to 15 weeks.

Utility Equipment

To control Fire Ants, Wasps and other insects as listed which commonly infest utility enclosures, cabinets conduits, junctions boxes, enclosed electrical panels and motor control rooms. Remove from sealed bag and hang or stand so air can contact all sides of the strip. Use a size appropriate for the space being treated: one (1) 5.25 g strip per 25 to 50 cu.ft. or one (1) 10.5 g strip per 50 to 100 cu. ft. or one (1) 21 g strip to treat 100 to 200 cu. ft. of enclosed space for utility equipment such as communications equipment, electric, gas, water and cable television. Record installation date and replace when effectiveness diminishes.

Reptile Houses and Terrariums

For control of mites on reptiles. **In Reptile Houses:** Hang appropriate number of (80) 65 g strips per 1,000 cu. ft. for the space to be treated. Do not over treat. **In Terrariums:** Cover the top of an open terrarium having a minimum size of 10 cubic feet with a wire screen and place a caged 10.5 or 21 g strip on the screen for 48 hours. Make sure that the reptiles cannot touch or contact the strip.

How much space will one strip treat?

100 grams	1,000 to 1,500 cu. ft.	8' x 12' x 15' = 1440 cu. ft.

Always use the appropriate size and number of strips for the space being treated. If more than one is required, distribute them over the space equally.

Do not use in any rooms or closets of rooms where infants, children and the sick or aged are or will be present for any extended period of confinement. 
The enclosed notification amendments are being submitted to update Storage and Disposal statements for the above subject products in accordance with PR-Notice 2001-6. Note that we submitted similar Notifications for these labels on April 11, 2003, but have since identified inconsistencies between the subject labels. These pest strip products are identical in use and formulation, but separate registrations are maintained to accommodate different supplemental distributor arrangements. Therefore, with this submission we have corrected typographical errors and other discrepancies so that the three attached labels now match, with the exception of the marketing supplement associated with EPA Reg. No. 5481-348 only.
