The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling:

- 1. Under "Directions for Use" add the statement: "For crack and crevice use only in homes, cabins, garages, basements, animal buildings, dairy milk rooms, warehouses, and industrial plants."
- 2. Under Directions for Use add: "For residential crack and crevice use, do not apply DDVP containing products more frequently than once per month."
- 3. Throughout the labeling qualify "food" with "feed." For example: "food/feed processing plants"; "nonfood/feed processing areas"; etc."
- 4. Under Directions add "Not for Use in Federally Inspected Meat and Poultry Plants."
- Under Directions change "edible product areas" to "food/feed handling areas."
- 6. The "Nonfood areas" statement should follow the sentence beginning "Do not use in edible product....."

Submit two copies of each final printed labeling before you release the products for shipment. A stamped copy of the labeling is enclosed for your records.
