DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. When ready to use, unwrap original package and follow ASSEMBLY INSTRUCTIONS. For Homes, Motels, Cabins, Garages: To control flies, mosquitoes, gnats, use one Amvac Insect Strip for an average size room (10 x 10 x 8 feet). Normally this is effective for four months. Replace strip if effectiveness diminishes.

INDUSTRIAL/COMMERCIAL

Garbage Cans & Trash Dumpsters

For control of flies in garbage cans and dumpsters attach Amvac Insect Strip inside can or dumpster. Keep lid on can and dumpster closed.

Animal Buildings

To control flies, mosquitoes, and gnats in Horse Barns, Calf Parlors, Hog Parlors, Stables, Poultry Houses, Tack Rooms and Dog Kennels, place one Amvac Insect Strip per 1,000 cu. ft. of space. If more than one strip is required, distribute them equally over area to be treated. Drafts, weather and other conditions may affect the performance, but these usually last four months. Replace when effectiveness diminishes. Do not contaminate food, water or foodstuffs. Do not contaminate milk or milking equipment.

Utility: To control Fire Ants, Wasps, and Bees which may commonly infest utility enclosures, cabinets, and junctions. Remove from sealed bag and hang so air can contact all sides of INSECT STRIP. Use INSECT STRIP in enclosed areas for utility equipment such as communications equipment, electric, gas, water and cable television. Record installation date and replace when effectiveness diminishes.

Milk Rooms

To control flies, mosquitoes, and gnats in milkrooms and bulk milk storage rooms hang one Insect Strip per 1,000 cu. ft. of space. Do not contaminate milk or milking equipment.

Catch Basin

To control Mosquitoes breeding in catch basins, suspend one Insect Strip about 10 inches above water line. Usual control is 10 to 15 weeks. Replace strip when effectiveness diminishes.

Agricultural Commodities

Bulk Storage of raw grains, corn, soybeans, cocoa beans, and peanuts. For control of Almond Moths, Cocoa Moth, Indian Meal Moth, and Mediterranean Flour Moths infesting non-perishable bulk stored raw agricultural commodities, suspend one Insect Strip per 1,000 sq. ft. of air space above the commodities before moths begin to emerge in early spring. Weather and drafts and other conditions effect the performance of the control, but this treatment usually lasts for four months. Replace strip when needed to prevent egg laying by moths.

HOUSEHOLD

Use as a Moth Killer

Protects clothes against clothes moths for up to 6 months and leaves no smell. Remove from sealed bag and hang on wardrobe rail, ensuring that strip does not contact clothes or fabrics and that air can circulate around the Amvac Moth Killer. One strip will treat a space of 50 cubic feet (a space 3 ft. x 3 ft. with a 6 foot ceiling) for up to six months. Record the date of installation so that the old strip may be replaced with a new, fresh, full strength strip at the end of the 6 month period or when effectiveness diminishes.

Use as a Small Space Fly Killer

Kills flies and other household insects all summer long. Remove from sealed bag and hang or stand anywhere, out of reach of children and pets, in an open space, away from windows. The "small space fly killer strip" controls flies, bees, earwigs, cockroaches, silverfish, mosquitoes, and other small household insects for up to 4 months. Do not use where unwrapped food is stored or allow the strip to come into contact with food or cooking utensils. Record the date of installation so that the old strip may be replaced with a new, fresh, full strength strip at the end of the 4 month period or when effectiveness diminishes.

Use as a Fly Killer

Kills flies and other insects all summer long. Remove from sealed bag and hang or stand anywhere, out of reach of children and pets, in an open space, away from windows. One Amvac Fly Killer Strip will treat 1,000 cubic feet which can be equal to an average room 10 x 13 with an 8 foot ceiling for up to 4 months. In a larger room if more than one strip is required, keep them at least 10 feet apart. To "shut off" the unit, simply close the slide control thus sealing the strip back into the package. Record the date of installation so that the old strip may be replaced with a new, fresh, full strength strip at the end of the 4 month period or when effectiveness diminishes.

Use as a Mini-Strip Insect Control

Household Insecticide. Kills moths and silverfish in closets, wardrobes and storage areas for up to 4 months. Gives continuous protection from moths, silverfish and cockroaches and other insects for up to 4 months. Use in confined spaces of up to 100 cubic feet (8 ft. x 8 ft. x 3 ft.). Space larger than this will require more than one mini-strip. Do not open inner pouch until ready to hang strip for use. Remove Amvac Mini-strip from sealed pack. Hang or place in enclosed space where protection is required. Locate Amvac Mini-strip so that direct contact with clothing cannot occur. Your Amvac Mini-strip should be replaced after 4 months. A replacement "reminder sticker" is enclosed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not open or remove from package before ready to install. Store in cool, dry place. Do not reuse packaging. Wrap used packaging in several layers of newspaper and discard in trash collection.
