Drafts, weather and other conditions may affect the performance, but treatment usually lasts for four (4) months. *(One \_\_\_g unit will treat \_\_\_ cu. ft.)*. Record the date of installation and replace with a new, fresh, full-strength strip at the end of four (4) months or when effectiveness diminishes. - Assembly Instructions for Non-Assembled Strip**
1. Gently squeeze edges of holder to open ends of unit.
  2. Press in bottom locking tabs to prevent strip from sliding out of holder.
  3. Without damaging the strip inside, carefully cut open the envelope with scissors. Slide bar into the holder at the top.
  4. Press in top locking tabs to secure strip inside.
  5. To hang, attach metal hook through hold of unit.

### HOUSEHOLD, INDUSTRIAL, AND COMMERCIAL USES

#### Homes, Ranches, Farms, Cabins, Garages, Storage Units, Attics, Crawlspace, Boathouses

Controls flies, mosquitoes, gnats and other insects as listed.

#### Garbage Cans, Trash Dumpsters

For control of flies in garbage cans and dumpsters, attach appropriate sized strip (From table: One \_\_\_-gram strip treats \_\_\_ to \_\_\_ cu. ft.) inside can or dumpster. Keep lid on can and dumpster closed.

#### Animal Buildings

Controls flies, mosquitoes and gnats in horse barns, calf parlors, hog parlors, stables, poultry houses, tack rooms and dog kennels. Do not contaminate food, water or foodstuffs. DO NOT contaminate milk or milking equipment.

#### Milk Rooms

Controls flies, mosquitoes and gnats in milk rooms and bulk storage rooms. DO NOT contaminate milk or milking equipment.

#### Agricultural Commodities

Bulk storage of raw grains such as: corn, soybeans, cocoa beans and peanuts. For control of stored product insects including Almond Moths, Cocoa Moths, Confused Flour Beetles, Indian Meal Moths, and Mediterranean Flour Moths infesting non-perishable bulk-stored raw agricultural commodities. Calculate cubic feet of air space above the commodity to determine the number of (65) 80 (100)-gram strips required for treatment. Treat in early Spring before moths begin to emerge. Replace strip when needed to prevent egg laying by moths. Hang strips so as not to impede air circulation. When multiple strips are required, distribute them uniformly over the treated space.

#### Catch Basins

To control mosquitoes breeding in catch basin, suspend one (65) 80-gram strip about ten inches above water level. Usual control lasts 10 to 15 weeks.

## Utility Equipment

To control Fire Ants, Wasps and other insects as listed which commonly infest utility enclosures, cabinets, conduits, junction boxes, enclosed electrical panels and motor control rooms. Remove from sealed bag and hang or stand so air can contact all sides of the strip. Use a size appropriate for the space being treated: one (1) 5.25 gram strip per 25 to 50 cu.ft. or one (1) 10.5-gram strip per 50 to 100 cu. ft. or one (1) 21-gram strip to treat 100 to 200 cu. ft. of enclosed space for utility equipment such as communications equipment, electric, gas, water and cable television. Record installation date and replace when effectiveness diminishes.

## Reptile Houses and Terrariums

*(Alternate wording in italics)* For control of mites on reptiles. **In Reptile Houses:** Hang appropriate number of (80) 65-gram strips per 1,000 cu. ft. for the space to be treated. Do not over treat. **In Terrariums:** Cover the top of an open terrarium having a minimum size of 10 cubic feet with a wire screen and place a caged 10.5 or 21-gram strip on the screen for 48 hours. Make sure that the reptiles can not touch or contact the strip.

### How much space will one strip treat?

80 grams	900 to 1,200 cu. ft.	8' x 10' x 15' = 1200 cu. Ft
100 grams	1,000 to 1,500 cu. ft.	8' x 12' x 15' = 1440 cu. Ft

## HOUSEHOLD USES

### Use only in Closets, Wardrobes, Cupboards and Storage Spaces

*(Alternate wording in italics)* Gives continuous protection against moths, silverfish, cockroaches and other insects as listed in closets, wardrobes and storage spaces for up to four (4) months and leaves no smell (*odor*). Remove strip\* from sealed bag and hang or stand on wardrobe or closet rail, ensuring that strip does not contact clothes or fabrics and that air can circulate around the strip\*. (*One \_\_\_ gram strip\* will treat a space of \_\_\_ to \_\_\_ cubic feet*). One 5.25 gram strip will treat a space of 25 to 50 cu. ft. One 10.5 gram strip will treat a space of 50 to 100 cu. ft. Use one 21-gram strip\* to treat 100 to 200 cu. ft. for up to four (4) months. If more than one is required, distribute them over the space equally. Keep the space closed. Record the date of installation so that the old strip\* may be replaced with a new, fresh, full-strength strip\* at the end of the four-month period or when effectiveness diminishes.

One (80) 65-gram strip\* will treat 900 to 1200 cubic feet which is about equal to an average room 10 x 13 with an 8-foot ceiling for up to 4 months. In a larger room, if more than one strip is required, keep them at least 10 feet apart. Record the date of installation so that the old strip may be replaced with a new, fresh, full-strength strip at the end of the four-month period or when effectiveness diminishes.
