The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. 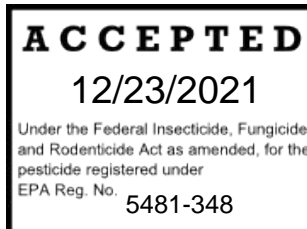

Keep the treated space closed. Do NOT use more than the number of strips recommended for the space to be treated. Do NOT use in closets and wardrobes of rooms where infants, children and the sick or aged are or will be present for any extended period of confinement. Do NOT use where unwrapped food is stored or allow the strip to come into contact with food or cooking utensils. In Animal Buildings:

This product controls flies, mosquitoes and gnats in horse barns, calf parlors, hog parlors, stables, poultry houses, tack rooms and dog kennels. Do NOT contaminate food, water, foodstuffs, milk or milking equipment.

In Milk Rooms:

This product controls flies, mosquitoes and gnats in milk rooms and bulk storage rooms. Do NOT contaminate milk or milking equipment.

In Agricultural Commodities:

For the bulk storage of raw grains such as corn, soybeans, cocoa beans and peanuts. This product controls fire ants, wasps and other insects as listed on this label which commonly infest utility enclosures, cabinets, conduits, junction boxes, enclosed electrical panels, motor control rooms and other utility equipment for communications, electric, gas, water and cable television. Place product so that air can contact all sides of the strip. Record installation date and replace when effectiveness diminishes.

In Reptile Houses and Terrariums:

This product controls mites on reptiles. In reptile houses, hang the appropriate number of strips for the space to be treated. Do not over-treat. In terrariums, cover the top of an open terrarium having a minimum size of 10 cu. ft. with a wire screen and place the strip on the screen for 48 hours. Make sure that the reptiles cannot touch or contact the strip. Remove the strip after the treatment interval.
