
Dear Ms. Naujock:

The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), to correct the signal word from DANGER to CAUTION has been reviewed and found to be acceptable.

In the last accepted EPA stamped label, dated July 26, 2010, we instructed you to change the signal word and the precautionary statements based on a finding that the acute eye irritation study (MRID #43494194) resulted in a Category I designation. After careful evaluation we have concluded that the Category should have been IV and that the signal word must be CAUTION.

Submit one copy of your final printed labeling before you release the product for shipment.

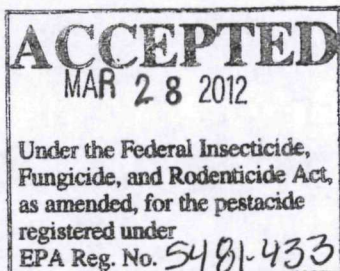

CAUTION

Formulation into a plant growth regulator is prohibited for use on pineapples. Formulators using this product are responsible for obtaining EPA registrations for their formulated products.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Avoid contact with other pesticides, seeds, fertilizers or feedstuffs. Do not use in equipment or in a container in which you have handled or will handle other agricultural chemicals unless thoroughly cleaned.

PESTICIDE STORAGE: Store product in original container in a cool, dry, locked place out of direct sunlight. Do not store or transport near feed or food.

PESTICIDE DISPOSAL: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or local procedures.

Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into the application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved State and local procedures.
