
The subject Agency Approval letter was stamped "Accepted with Comments" with the condition that specific label revisions be made. Please note that the "Subject" of the December 23, 2011 approval letter should have been "Vapam Manufacturing Concentrate" instead of "Metam Manufacturing Use Concentrate." This subsequent letter hereby further amends the subject by adding the following revisions:

1. Disregard revision number 2 of the December 23, 2011 approval letter. Instead, on page 2 of the label, under "Directions for Use," below "Only for formulation into a fumigant for the following use(s):" add the following text: "Fumigant solutions for the control of decay and insects in wood or wood products; antimicrobial agents; and products to control roots and fungi in sewers. Fumigant solutions for the control of weeds, fungi and nematodes in soil of the following crops:"
2. On page 2, under "Directions for Use," replace "[Name of Product]" with "end-use product."
3. On page 4, in the Contents of Sign, delete "and metam potassium."
4. Please note a company website is listed. Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance

Assurance. As an alternative, you may refer consumers to the company's phone number or e-mail address.

Submit one copy of the final printed label that incorporates the aforementioned deletion request before the product is released for shipment. Please ensure labeling requirements are met as outlined in 40 CFR Part 156.
