The Amvac Insecticide Chip is for use as a toxicant in insect traps, including those for cotton boil weevil, gypsy moth, spruce budworm, forest tent caterpillar, fruit flies, codling moth, southwestern corn borer, pepper weevil and sweet potato weevil. For proper function of this product Insect traps should be designed to position the "vapor releasing" Chip in a confined insect trapping chamber where insects will be trapped in closed vicinity to the Chip's surface and vapors. Read directions for use accompanying the trap before opening the Insecticide Chip package. Replace Chips every 5 weeks.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not open or remove from package before ready to use. Store in a cool, dry place. Do not reuse packaging or chips. Wrap and discard in trash.
