Your Submission, Dated October 27, 2003, as Amended October 30, 2003

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Add the following dermal sensitization statement under "Hazards to Humans and Domestic Animals":

"Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

FMC Corporation recently submitted a new dermal sensitization study for Bifenthrin Technical (EPA Reg. No. 279-3055). Based on the results of the study, FMC's technical has been classified as a dermal sensitizer and the above statement has been added to the product label. Since your product was registered based on its substantial similarity to FMC's technical, it is also classified as a dermal sensitizer. Accordingly, you must also add the statement shown above to your product label.

2. In the Directions for Use, under "Food Handling Establishments", delete the paragraph "Non-Food/Feed Areas". The statements in this paragraph imply that the product may only be used to formulate insecticides for use in non-food/feed areas of food handling establishments. It is our understanding that you intend to allow formulation into products for use in both non-food/feed and food/feed areas of food handling establishments.

3. Revise the last sentence of the third paragraph under "Limited Warranty and Disclaimer" to read "To the extent allowed by law, manufacturer or seller shall not be liable for any special, indirect or consequential damages resulting from the use or handling of this product." As currently written ("In no event, shall manufacturer or seller be liable ...") the statement negates and/or detracts from labeling requirements as set forth by the Agency in 40 CFR Part 156, and is, therefore, considered misbranding.

#### STORAGE AND DISPOSAL

#### Pesticide Storage

Do not freeze. Do not store below 40°F. If solid crystals are observed, warm material to above 60°F by placing container in warm location. Shake or roll container periodically to redissolve solids.

Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers.
