STORAGE AND DISPOSAL

Pesticide Storage

Do not freeze. Do not store below 40°F. If solid crystals are observed, warm material to above 60°F by placing container in warm location. Shake or roll container periodically to redissolve solids.

Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Do not cut or weld metal containers.
