#### NOTE TO PHYSICIAN

Warning symptoms include weakness, headache, tightness in chest, blurred vision, nonreactive pinpoint pupils, salivation, nausea, vomiting, diarrhea, and abdominal cramps. Give atropine intramuscularly or intravenously, depending on severity of poisoning, 2 to 4 milligrams every 10 minutes until fully atropinized as shown by dilated pupils, dry flushed skin and tachycardia. Twenty to thirty milligrams, or more, may be required during the first 24 hours. Never give opiates or phenothiazine tranquilizers. Clear chest by postural drainage. Artificial respiration or oxygen administration may be necessary. Observe patient continuously for at least 48 hours. Allow no further exposure to any cholinesterase inhibitor until cholinesterase regeneration has taken place as determined by blood tests. Probable mucosal damage may contraindicate the use of gastric lavage.

Pralidoxime chloride (2-PAM; PROTOPAM chloride) may be effective as an adjunct to atropine. Use according to label directions.

#### **ENGINEERING CONTROLS**

This product is formulated into Lock 'N Load <u>Alternate Wording when packaged in SMARTBOX</u>. SMARTBOX, an enclosed system that meets the definition of a closed loading system as defined by the Worker Protection Standard for Agricultural Pesticides [40 CFR 170.240(d)(4)]. In addition to wearing the required PPE for handlers using engineering controls, loaders must be provided and must have immediately available for use and must wear if a broken package, spill or equipment breakdown occurs:

- protective eyewear,
- · chemical-resistant apron,
- chemical-resistant footwear, and
- NIOSH-approved dust/mist filtering respirator with MSHA/NIOSH approval number prefix TC-21C or a NIOSH approved respirator with any N, R, P, or HE filter.

Applicators must use an enclosed cab that meets the definition in the Worker Protection Standard for Agricultural Pesticides for dermal protection. In addition the applicator:

#### **ENVIRONMENTAL HAZARDS**

This pesticide is very highly toxic to fish and wildlife.

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean highwater mark. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment wastewater or rinsate.

#### **DIRECTIONS FOR USE**

Do not apply more than one application of **Thimet 20-G** per crop per season.

Do not apply this product to saturated soils. Do not apply in wet soil conditions that may prevent the equipment from covering pesticide granules. Do not apply while precipitation conducive to runoff is occurring or while conditions favor runoff from the treated area. Do not apply when forecasted precipitation event favors runoff from treated area.

Under some conditions phorate may have a high potential for runoff into surface water for several days following application. Do not apply in the following areas:

- Frequently flooded areas
- Areas where intense or sustained rainfall is forecast to occur within 48 hours

Use Best Management Practices (BMPs) for minimizing surface runoff in the following areas:

- Poorly drained or wet soils with readily visible slopes toward adjacent surface water
- Areas over-laying extremely shallow ground water
- Areas with in-field canals or ditches that drain to surface water
- Areas not separated from adjacent surface waters with vegetated filter strips
- Areas over-laying tile drainage systems that drain to surface water

When used on erodible soils, BMPs for minimizing runoff should be followed. Consult your local soil conservation service for recommendations in your use area.

In particular, where highly erodible land (HEL) is adjacent to aquatic bodies, a 66 foot buffer/setback area should be left in grass or other natural vegetation.

Do not wash, load, or empty application equipment near any well, as this practice is a potential source of ground water contamination.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), notification to workers, and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 48 hours. Each 48-hour REI is increased to 72 hours in outdoor areas where average annual rainfall is less than 25 inches a year.

To determine other use rates, in pounds per acre:

Take desired rate (ounces) and divide by 1,000 ft of row, divide by 16 oz/lb, divide by row width in feet, multiply by  $43,560 \text{ ft}^2/A = \text{lb/A}$ .

Example: For 10 oz in 1,000 ft of row, 36 inch row width (3 ft):
