Remove from sealed bag and hang or stand so air can contact all sides of the strip. One strip treats 900 to 1200 cubic feet. Record installation date and replace when effectiveness diminishes.

Reptile Houses Occupied by People for Less than 4 Hours Per Day

For control of mites on reptiles. **In Reptile Houses:** Hang appropriate number of (80) 65 g strips per 1,000 cu. ft. for the space to be treated. Do not over treat.
