Subject: Amendment – Response to Feb 21, 2008 letter implementing spray drift language and Permethrin RED risk mitigation labeling

Ambush Insecticide EPA Reg. No. 5481-549 Your submission dated August 13, 2008

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. In the ingredients statement, add a double asterisk after "Inert Ingredients" to refer down to a second footnote as follows: "** Contains petroleum distillates".
 - b. In the First Aid "If swallowed" advice, replace "Have person sip a glass of water if able to swallow." with "Do not give any liquid to the person.". Also, at the bottom of the First Aid section, add a "Note to Physician" as follows "Probable mucosal damage may contraindicate the use of gastric lavage. May cause aspiration pneumonia hazard.".
 - c. Revise the heading PERSONAL PROTECTIVE EQUIPMENT to read PERSONAL PROTECTIVE EQUIPMENT (PPE).

d. Under the heading PERSONAL PROTECTIVE EQUIPMENT (PPE), after the paragraph beginning "Some materials..." add the following subheading and text (due to the fogging use for mushroom houses):

Applicators using ULV cold foggers and/or fog/mist generators in indoor spaces must wear:

- · Coveralls over long-sleeved shirt and pants
- Chemical-resistant gloves
- · Chemical-resistant footwear plus socks, and
- Chemical-resistant headgear if overhead exposure
- e. Also in the PERSONAL PROTECTIVE EQUIPMENT (PPE) section, revise the next subheading to read: "All other mixers, loaders, applicators, and other handlers must wear:". In the last bulleted item of this subsection, delete "and for handlers performing animal dip applications" since there are no directions for such a use on this label.
- f. Add an outline box enclosing the heading USER SAFETY REQUIREMENTS and the associated two bullets.
- g. Directly under the heading DIRECTIONS FOR USE add "RESTRICTED USE PESTICIDE" in bold print.
- h. Under the heading "BUFFER ZONES", correct the website URL (address) for guidance to read as follows: www.in.nrcs.usda.gov/technical/agronomy/newconbuf.pdf. Also, add headings for Buffer Zones for Aerial Application (both ULV and non-ULV, if that is what your label directions permit). For all buffer zone headings, qualify the site "ponds" to read "natural ponds" and qualify "streams" to read "permanent streams".
- i. Under the heading "CHEMIGATION", delete Use Precaution "L", "Do not apply when wind speed favors drift beyond the area intended for treatment.". The appropriate spray drift precautions now appear under the heading "SPRAY DRIFT REQUIREMENTS".
- j. In the REMARKS for each crop giving the maximum rate per application and the seasonal maximum application rate, give both the ounces of formulated product and the pounds active per acre for both entries. For example, revise the entries to read "Do not apply more than X oz. of product (Y lbs. a.i.)/A per application or more than X oz. of product (Y lbs. a.i.) per acre per season". Substitute X and Y with the appropriate value for each crop.
- k. For many crops, although the "LBS AI/A" Rate was revised, the "Oz/A" Rate was not adjusted accordingly. For Broccoli, revise the "OZ/A" Rate entry to read "(3.2 12.8)"
- 1. For Chinese Broccoli, revise the "OZ/A" Rate entry to read "(3.2 12.8)".
- m. For Collards, revise the "OZ/A" Rate entry to read "(3.2-9.6)"

bb. For Pine Seed Orchards, in the REMARKS add the following as the last item:

PROHIBITION - Harvesting of conifer seed cones is prohibited within 30 days of application.

- cc. For ROSES (Greenhouse), indicate the type of application equipment (such as pump spray or power spray) and whether ULV and/or mist or fogging equipment is permitted or prohibited, since this could affect the PPE required.
- dd. In the Rate Conversion chart, you may want to add 0.25 pounds active/acre and its associated conversions since this is a rate appearing for fruit tree crops and add 0.3 pounds active/acre and its associated conversions since this is a rate appearing for pistachios and for onions.
- ee. For the Storage and Disposal section, include the label revisions specified by PR Notice 2007-4, which is available at www.epa.gov/opppmsd1/PR_Notices/pr2007-4.pdf .
- ff. In the third paragraph of the Limited Warranty and Disclaimer, add "To the extent permitted by law" before "in no event shall...".

A stamped copy of the label is enclosed for your records. Please submit three copies of the amended labeling bearing the above revisions before you release the amended label for shipment. Please note that acceptance of this amendment does <u>not</u> constitute reregistration of the subject product.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS WARNING

Harmful if swallowed or absorbed through skin. May cause eye irritation. Avoid contact with eyes, skin or clothing. Avoid breathing vapor or spray mist.

PERSONAL PROTECTIVE EQUIPMENT

ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish and aquatic organisms, including fish and invertebrates. Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Drift and runoff from treated areas may be

hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

Under some conditions, it may also have a potential for transport into surface water in runoff (primarily adsorbed to suspended soil particles), for several months or more after application. These include poorly draining or wet soils with readily visible slopes toward adjacent surface waters, frequently flooded areas, and areas overlying extremely shallow groundwater, areas with in-field canals or ditches that drain to surface water, areas not separated from adjacent surface waters with vegetated filter strips, and areas over-lying tile drainage systems that drain to surface waters.

This pesticide is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are actively visiting the treatment area.

PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat or open flame.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

Use of high pressure hand wand prohibited in mushroom houses.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours.

GENERAL PRECAUTIONS AND RESTRICTIONS

BUFFER ZONES

Vegetative Buffer Strip

Construct and maintain a minimum 10-foot wide vegetative filter strip of grass or other permanent vegetation between the field edge and down gradient aquatic habitat (such as, but not limited to, lakes; reservoirs; rivers; permanent streams; marshes or natural ponds; estuaries; and commercial fish farm ponds).

Only apply products containing permethrin onto fields where a maintained vegetative buffer strip of at least 10 feet exists between the field and down gradient aquatic habitat.

Buffer Zone for Ground Application (ground boom, overhead chemigation, or air blast)

Do not apply within 25 feet of aquatic habitats (such as, but not limited to, lakes, reservoirs, rivers, streams, marshes, ponds, estuaries, and commercial fish ponds).

SPRAY DRIFT REQUIREMENTS

Wind Direction and Speed

Only apply this product if the wind direction favors on-target deposition.

Do not apply when the wind velocity exceeds 15 mph.

Temperature Inversion

Do not make aerial or ground applications into temperature inversions.

Inversions are characterized by stable air and increasing temperatures with height above the ground. Mist or fog may indicate the presence of an inversion in humid areas. The applicator may detect the presence of an inversion by producing smoke and observing a smoke layer near the ground surface.

Droplet Size

Use only Medium or coarser spray nozzles (for ground and non-ULV aerial application) according to ASAE (S572) definition for standard nozzles. In conditions of low humidity and high temperatures, applicators should use a coarser droplet size.

Additional Requirements for Ground Applications

Wind speed must be measured adjacent to the application site on the upwind side, immediately prior to application.

For ground boom applications, apply using a nozzle height of no more than 4 feet above the ground or crop canopy.

For air blast applications, turn off outward pointing nozzles at row ends and when spraying the outer two rows. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

Additional Requirements for Aerial Applications

The spray boom should be mounted on the aircraft as to minimize drift caused by wingtip or rotor vortices. The minimum practical boom length should be used and must not exceed 75% of the wing span or 80% rotor diameter.

Flight speed and nozzle orientation must be considered in determining droplet size.

Spray must be released at the lowest height consistent with pest control and flight safety. Do not release spray at a height greater than 10 feet above the crop canopy unless a greater height is required for aircraft safety. When applications are made with a cross-wind, the swath will be displaced downwind. The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind.

GENERAL INSTRUCTIONS

Apply AMBUSH Insecticide as shown in **Directions for Application**. Use sufficient water to obtain full coverage of foliage. Timing and frequency of applications should be based upon insect populations reaching economic thresholds. The higher rates may be required under conditions of heavy infestation. Do not apply more than 2.0 lbs. a.i./A per season. Crops in this label may be planted immediately after last treatment. Do not plant other crops within 60 days after last application. Any other crop may be planted if it is not harvested or grazed.

Resistance

Some insects are known to develop resistance to products used repeatedly for control. Because the development of resistance cannot be predicted, the use of this product should conform to resistance management strategies established for the use area. Consult your local or state agricultural authorities for details.

If resistance to this product develops in your area, this product, or other products with a similar mode of action, may not provide adequate control. If poor performance cannot be attributed to improper application or extreme weather conditions, a resistant strain of insect may be present. If you experience difficulty with control and resistance is a reasonable cause, immediately consult your local company representative or agricultural advisor for the best alternative method of control for your area.

CHEMIGATION

Sprinkler Irrigation Application: Apply AMBUSH Insecticide at rates and timing described elsewhere in this label. Apply with center pivot or continuous-move equipment distributing 1/2 acre-inch or less during treatment. If stationary (solid sets, handlines or wheel lines other than continuous-move) are used, AMBUSH Insecticide should be injected into no more than the last 20-30 minutes of the set. Do not apply when winds are greater than 10-15 mph to avoid drifts or wind skips. Thorough coverage of foliage is required for good control. Good agitation should be maintained during the entire application period.

USE PRECAUTIONS – SPRINKLER IRRIGATION APPLICATION

- A. Apply this product only through (sprinkler including center pivot, lateral move, end tow, side [wheel] roll, traveler, big gun, solid set, or hand move) irrigation system(s). Do not apply this product through any other type of irrigation system.
- B. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from nonuniform distribution of treated water.
- C. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.
- D. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.
- E. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.
- F. The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- G. The pesticide injection pipeline must also contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
- H. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
- I. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- J. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- K. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- L. Do not apply when wind speed favors drift beyond the area intended for treatment.
- M. Do not apply through chemigation systems connected to public water systems.

COMMERCIAL IMPREGNATION AND APPLICATION OF AMBUSH INSECTICIDE ON DRY BULK FERTILIZER

AMBUSH Insecticide may be impregnated on dry bulk fertilizers. When applied as directed, AMBUSH Insecticide/dry bulk fertilizer mixtures provide insect control equal to the same rate of AMBUSH Insecticide applied in water.

Bulk fertilizer impregnated with AMBUSH Insecticide should be applied immediately, not stored. The AMBUSH Insecticide/fertilizer mixtures may be surface applied or shallow incorporated. If shallow incorporated, the higher rate of AMBUSH Insecticide should be used.

Apply using a minimum of 200 lb. and a maximum of 450 lb. of dry bulk fertilizer/A with the recommended amount of AMBUSH Insecticide/A.

For impregnation of AMBUSH Insecticide on dry fertilizers, use a closed rotary-drum mixer or a similar type of closed blender equipped with suitable spray equipment. The spray nozzle (or nozzles) should be positioned inside of the mixer to provide uniform spray coverage of the tumbling fertilizer. AMBUSH Insecticide should be sprayed uniformly onto the fertilizer using a fine spray pattern.

The physical properties of fertilizers vary, particularly in liquid absorptive capacity. When absorptivity is sufficient, simple spray impregnation of the fertilizer with AMBUSH Insecticide provides a satisfactory dry mixture.

If the absorptive capacity is inadequate, use of a highly absorptive powder is required to provide a dry, free-flowing mixture. Micro-CelTM E (Manville Sales Corp.) is the recommended absorbent powder. It should be added separately and uniformly to the prepared AMBUSH Insecticide fertilizer mixture in a quantity that is sufficient to provide a suitably free-flowing mixture. Generally less than 2% by weight of Micro-CelTM E is required.

DO NOT impregnate AMBUSH Insecticide onto straight coated ammonium nitrate or straight limestone because these materials will not absorb the insecticide. Dry fertilizer blends containing mixtures of ammonium nitrate or limestone may be impregnated with AMBUSH Insecticide.

The amount of AMBUSH Insecticide actually required in the manufacture of individual fertilizer mixtures should be determined carefully for each production operation. This is necessary to ensure that the amount of AMBUSH Insecticide actually contained in the mixture applied to the soil represents the correct rate of use.

All individual state regulations relating to bulk dry fertilizer blending, registration, labeling and application of the mixtures are the responsibility of the individual and/or company selling the fertilizer and AMBUSH Insecticide mixture.
