The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



- AMVAC Small Pro-Strip is intended for sale to and use by pest management professionals ONLY. This product is NOT intended for sale to or use by homeowners.
- Do NOT apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.
- This product is NOT permitted for use in the food/feed areas (areas for receiving, storing, packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) of food/feed processing or food/feed manufacturing or food/feed service establishments. Serving areas where food is exposed and the facility is in operation are also considered food areas.
- Do NOT use in any area of the home where people will be present for more than four (4) hours per day.
- Do NOT allow children or pets to play or sleep in these areas when treatment is in progress.
- This product is NOT to be taken internally by humans or animals.

How it works: AMVAC Small Pro-Strips utilizes controlled release technology to slowly diffuse a deep penetrating vapor in enclosed spaces for up to 4 months. The clean, odorless vapor is evenly distributed throughout the enclosed treatment area, killing visible and hidden insects on contact and preventing new insect infestations [while you're away].

AMVAC Small Pro-Strips may be used only in UNOCCUPIED areas including garages, sheds, attics, crawl spaces, pantries, cupboards, closets, museums, museum collections, reptile houses, terrariums, animal buildings, barns, milk rooms, storage units, storage bins, garbage cans, trash bins, trash dumpsters, bulk raw grain bins, pest traps, enclosed utility boxes, vacation homes, cabins, out-houses, mobile homes, recreational vehicles, transportation vehicles, including cars, trucks, vans, buses, and train and trolley cars (for bed bug control only -- see bed bug control section of this label), boats, boathouses, farm houses, ranch houses, catch basins and food serving areas that are not in operation and have no exposed food for less than (4) hours per day.

Food/feed areas of these establishments where the product is NOT permitted for use are areas for receiving, storing, packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) of food. Serving areas where food is exposed and the facility is in operation are also considered food areas. Strips may also be used in areas where non-perishable packaged, bagged or bulk raw and processed agricultural commodities (including corn, soybeans, grains, cocoa beans, and peanuts) are stored. Non-food/feed areas of these establishments where the product CAN be used are areas such as garbage rooms, lavatories, floor drains (to sewer), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, utility equipment, garages, mop closets, and product storage (after canning or bottling).

Within homes, use only in closets, wardrobes, cupboards, garages, attics and enclosed crawl spaces (except when following the bed bug control directions for use listed on this label).

AMVAC Small Pro-Strips Controls Flying and Crawling Pests including Ants (including Argentine Ants, Carpenter Ants, Fire Ants, Odorous House Ants, and Pavement Ants), Bed bugs, Bees (including Bumble Bees and Carpenter Bees), Beetles (including Asian Lady Beetles and Ladybird Beetles, Dermestid Beetles or Carpet Beetles or Hide Beetles, Flour Beetles including Red Flour Beetles and Confused Flour Beetles, Grain Weevils, Khapra Beetles, Litter Beetles or Lesser Mealworms or Darkling Beetles, Merchant Grain Beetles, Rice Weevils, Saw-Toothed Grain Beetles, Spider Beetles, and Warehouse Beetles), Boxelder Bugs, Cockroaches, Crickets, Earwigs, Firebrats, Flies (including Biting Flies, Filth Flies, Fruit Flies, and

House flies), Gnats (including Fungus Gnats), General Grain Pests, Grasshoppers, Hornets, Lesser Grain Borers, Millipedes, Mites (including Clover Mites and Harvester Mites), Moths (including Indianmeal Moths, Angoumois Grain Moths, and Tobacco Moths), General Pantry Pests, Pillbugs, Psocids, Silverfish, Sowbugs, Spiders, Springtails, Termite Swarmers, Wasps and other labeled pests as listed.

Wearing gloves, remove the strip from sealed bag when ready to use and place strip in provided holder if treatment area is routinely accessed by people or pets. Place Pro-Strip uniformly in the area to be treated to facilitate a uniform treatment of the space. Place (*Hang*) in desired location away from windows and out of reach of children and pets. (*To apply strips to vertical surfaces, use the enclosed stickers*). Record the date of installation and replace with a new, fresh, full-strength strip at the end of four (4) months or when effectiveness diminishes. When properly placed, strips provide control of pests for up to four months depending upon local conditions.

HOUSEHOLD, INDUSTRIAL AND COMMERCIAL USES

Within Homes, Use Only in Closets, Wardrobes, Cupboards, Garages, Attics and Enclosed Crawl Spaces (except when following the bed bug control directions for use listed on this label) Occupied Less than (4) Hours per Day. Also for use in Storage Units and Boathouses Occupied for Less than (4) Hours per Day.

AMVAC Small Pro-Strip kills flies, mosquitoes, gnats and other listed insects for up to four (4) months. Wearing gloves, remove the strip from sealed bag when ready to use and place strip in provided holder if treatment area is routinely accessed by people or pets. Hang or place, out of reach of children and pets, in an open space of an enclosed area, away from windows. Do NOT allow children to handle new or used strips. [One ___ gram strip will treat up to ___ cubic feet]. Replace with a new Pro-Strip at the end of four (4) months or as needed.

Garbage Cans, Trash Dumpsters and Trash Receptacles

For control of listed flying and crawling pests, place the appropriate number of Strips within trash receptacles such as compactors, garbage chutes, garbage rooms, garbage bins and others. Pro-Strip provides control of pests within trash receptacles for up to four (4) months.

Animal Buildings Occupied for Less than Four (4) Hours Per Day

Use AMVAC Small Pro-Strip to control pests in animal buildings including stalls, barns, milk rooms, kennels, pens, poultry houses, manure storage and other such areas. Do NOT contaminate milk. Place strip in manure collection areas such as beneath egg layers and broilers but do not allow strip to be placed in areas directly occupied by poultry. Place the appropriate number of strips for the space to be treated. Pro-Strip will control pests for up to four (4) months.

Milk Rooms Occupied for Less than Four (4) Hours Per Day

AMVAC Small Pro-Strip controls flies, mosquitoes and gnats in milk rooms and bulk storage rooms. Do NOT contaminate milk or milking equipment.

Agricultural Commodities

Use AMVAC Small Pro-Strip to control pests of non-perishable agricultural commodities, grains, bulk foodstuffs, packaged foods and other similar items. Do NOT contaminate foods. Place the appropriate number of strips for the headspace (volume) to be treated. Pro-Strip will control pests for up to four (4) months.

Catch Basins and Underground Stormwater Systems

Use AMVAC Small Pro-Strip to control mosquitoes and other labeled pests in Catch Basins and Underground Stormwater Systems where mosquitoes may live, breed and/or seek harborage. Place the appropriate number of strips for the space to be treated. Place strip by suspending above the water surface to control mosquitoes. Pro-Strip may control mosquitoes for up to four (4) months.

Enclosed Utility Boxes and Utility Chases

Use AMVAC Small Pro-Strip to control ants (including fire ants), spiders, wasps, hornets and other labeled pests within electric junction boxes, plumbing control boxes, pump houses and other such utility boxes as

needed. Place the proper number of strips for the space to be treated. Pro-Strip will control pests for up to four (4) months.

Reptile Houses and Terrariums Occupied by People for Less than four (4) Hours Per Day

Use AMVAC Small Pro-Strip to control mites on reptiles and other labeled pests in reptile enclosures, displays, reptile houses and terrariums. Place strip such that the reptile and desired animals within the enclosure or terrarium will not come in direct contact with the strip. Do NOT over treat. Strip is NOT intended for treatment of aviaries or birdcages. Place the appropriate number of strips in a suitable place to provide control. Strip must be removed after the 48 hour treatment interval.

Museum Collections Occupied by People for Less than four (4) Hours Per Day

Use AMVAC Small Pro-Strip to protect museum collections and other similar materials from damaging pests when this is a concern. Place strip in close proximity or within collection boxes using care to avoid contact with collectible and valuable items.

For Control of Bed bugs and Bed bug Eggs

AMVAC Small Pro-Strip may be used to control bed bug nymphs and adults exposed to product vapors for 48 hours. In difficult to treat areas, a minimum treatment time of 72 hours will provide better results. To kill bed bug eggs, confine vapors in the treated space for seven days. Do NOT allow children to handle plastic treatment bags or treatment poly sheeting or new or used strips.

AMVAC Small Pro-Strip may be used to control bed bugs that have entered various items in an infested structure, including electronics, appliances, footwear, art work, collectibles, plush toys, clocks, radios, wall hangings, telephones, computers, printers, mattresses, box springs, books, lamps, furniture and other such items. Take care to avoid direct contact of the strip with the surface of items being treated.

Place infested items in a suitable plastic bag that is completely sealed using tape, twist ties or other means, poly sheeting that is completely sealed off by adhesive tape on all sides, container or room that is closed and sealed off to contain the strip treatment. Plastic bags or poly sheeting must be at least 2 mils thick. Any mattress or box springs to be treated must be fully enclosed with a single strip within a large plastic bag or within poly sheeting with all edges taped closed. Seal plastic bags and poly sheeting with as much air space around the treated article as is practical as this will enhance the exposure to the product vapors. Proper seal can be attained by any appropriate manner such as the use of tape, twist ties or other means. Do NOT sleep or lay on mattress while in treatment bag. The closed volume for treatment should not exceed the volume to be treated for the size of the strip used.

Professionals should test for adequate seal by testing for the escape of air from the sealed bag. Identify sealed treatment by a label indicating a pesticide treatment is in process that should not be disturbed by unauthorized persons. The label should include the date, pest professional person or company responsible and contact telephone number.

When treatment is completed, remove treated items from the treatment in a well-ventilated area and air out for a period of not less than two hours. Discard plastic treatment bag or treatment poly sheeting and used strip in trash.

When an unoccupied room is properly closed and sealed to contain the product vapors, it may be located in a home, apartment, hotel, motel, school or other residential, commercial or industrial building. Identify sealed treatment by a label indicating a pesticide treatment is in process that should not be disturbed by unauthorized persons. The label should include the date, pest professional person or company responsible and contact telephone number. When a room treatment is completed, the strips must be removed and discarded in trash. The room must be aired out for a period of not less than two hours before it is re-occupied.

AMVAC Small Pro-Strips may be used to control bed bugs in transportation vehicles, including cars, trucks, vans, buses and train and trolley cars. **Vehicles must not be used during the bed bug treatment.** Place the appropriate number of strips in a vehicle that is then closed/sealed to contain the product vapors. The strips must remain in place for 72 hours to control bed bug nymphs and adults and for one week to control bed bug eggs. The ambient temperature should be at least 60° F during the treatment. Identify the vehicle by a label indicating a pesticide treatment is in process that must not be disturbed by unauthorized persons. The label must include the date, pest professional person or company responsible and a contact telephone number. When the treatment is complete, remove the strip(s) in a well ventilated area and air out the vehicle for a period of not less than two hours.

Always use the appropriate size and number of strips for the space being treated. [One ___g strip will treat a space of up to ___ cubic feet]. {NOTE TO REVIEWER: Optional wording depending on size strip}. See Table under Product Information Section. If more than one is required, distribute them within the space equally. The closed volume for treatment should not exceed the volume to be treated for the size of the strip used.

HOUSEHOLD USES

Within Homes, Use Only in Closets, Wardrobes, Cupboards, Garages, Attics and Enclosed Crawl Spaces (except when following the bed bug control directions for use listed on this label) Occupied Less than Four (4) Hours per Day. Also for use in Storage Units and Boathouses Occupied Less than Four (4) Hours per Day

AMVAC Small Pro-Strip gives continuous protection against moths, silverfish, cockroaches and other labeled in closets, wardrobes and cupboards for up to four (4) months and leaves no smell (*odor*). Wearing gloves, remove the strip from sealed bag when ready to use and place strip in provided holder if treatment area is routinely accessed by people or pets. Hang or stand on wardrobe or closet rail, ensuring that strip does not contact clothes or fabrics and that air can circulate around the strip. [One ___g strip will treat a space of up to ___ cubic feet]. {NOTE TO REVIEWER: Optional wording depending on size strip}. See Table under Product Information section. If more than one is required, distribute them within the space equally. Keep the space closed. Record the date of installation so that the old strip may be replaced with a new, fresh, full-strength strip at the end of the four (4) month period or when effectiveness diminishes. Do NOT use more than the number of strips recommended for the space to be treated.

Do NOT use in closets and wardrobes of rooms where infants, children and the sick or aged are or will be present for any extended period of confinement. Do NOT use where unwrapped food is stored or allow the strip to come into contact with food or cooking utensils. Do NOT allow children or pets to play or sleep in these areas when treatment is in progress. Do NOT allow children to handle new or used strips.

Attics, Garages and Enclosed Crawl Spaces

DO NOT USE IN AREAS WHERE PEOPLE WILL BE PRESENT FOR MORE THAN FOUR (4) HOURS PER DAY.

AMVAC Small Pro-Strip kills flies and other listed insects as listed for up to four (4) months. Wearing gloves, remove the strip from sealed bag when ready to use and place strip in provided holder if treatment area is routinely accessed by people or pets. Do NOT allow children to handle new or used strips. Hang or stand, out of reach of children and pets, in an open space of an enclosed area, away from windows. Calculate cubic feet of air space to determine the number of strips required for treatment [One ___g strip will treat a space of up to ___ cubic feet]. {NOTE TO REVIEWER: Optional wording depending on size strip}. See Table under Product Information section. Hang strips so as not to impede air circulation. When multiple strips are required, distribute them uniformly within the treated space. Record the date of installation so that the old strip may be replaced with a new, fresh, full-strength strip at the end of the four (4) month period or when effectiveness diminishes.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store product in original container in a secure locked area in a location that is inaccessible to children and pets. **DO NOT** contaminate water, other pesticides, fertilizer, food or feed in storage. **DO NOT** open or remove package before ready to install. Not for use or storage in or around the home.
