 - e) Replace all "Pro-Strip may be used to" with "Use Pro-Strip to" and "Pro-Strip may be placed ... etc and Pro-Strip should be placed ... etc" with "Place Pro-Strip ... etc"

f) Under Directions for Use revise the statement to read;

Add the following statement that identifies the food/feed areas where the product cannot be used i.e., "Food/feed areas of these establishments where the product is not permitted for use are areas for receiving, storing, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) of food. Serving areas where food is exposed and the facility is in operation are also considered food areas" after the sentence "Do not use in the food/feed areas of food/feed processing or food/feed manufacturing or food/feed service establishments".

g) On the front panel and throughout the label delete the word "Recommended" in the statement "Recommended for Use by Pest Management Professionals".

h) On page 2, delete "but not limited to" in the statement beginning, Pro Strips may be placed in unoccupied areas ... etc" Also delete the sites "pantries, cupboards closets" since these sites are considered residential and limited to the lb., 10.5 and 5.25 gm strips.

i) On page 3 under Agricultural Commodities add "non-perishable" to the statement beginning, "Pro-Strip may be used to control pests of non-perishable agricultural commodities ... etc"

j) On page 3 add "Occupied by People for less than 4 hours per day" following the heading Reptile Houses and Terrariums.

k) On page 3 delete "bath traps". We do not know how a strip can be used in a bath trap in a residential area.

l) On page 4 delete "and other such areas" in the sentence beginning" Pro-Strip may be used to control mites on reptiles and ... etc"

m) On page 4 add, the statement indicated in comment (j) above following the heading "Museum Collections"

n) Under Marketing Claims:

- (1) Delete "and more (other)**".
- (2) Add as asterisk following "Where to Use" under Product Facts and another * under the heading "Where to Use"

o) Add "To the extent consistent with applicable law" to the front of the statements "The manufacturer neither makes nor intends, nor does it authorize any agent or representative, to make any other warranties ending ... any warranty of quality or performance" and "In no event, shall manufacturer or seller be liable for special ... etc" in the Warranty and Disclaimer statement.

3. Please submit three (3) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). One (80) 65 g strip will treat 900-1200 cu. ft. which is about equal to an average room 10' x 13' with an 8-foot ceiling for up to four (4) months. In a larger room if more than one strip is required, keep them at least 10 feet apart. Record the date of installation so that the old strip may be replaced with a new, fresh, full strength strip at the end of the four (4) month period or when effectiveness diminishes.
