Dear Mr. Wood;

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- Delete claims against fleas, ticks, and centipedes. These claims are not supported by the submitted data.
- On page 2, under Directions for use, delete "...and other such places" and "...and other such materials."
- Move the statements on top of page 3 "*For use in unoccupied areas; not for use in homes...Also for use in boathouses... 4 hours per day*" directly under the heading "*Household, Industrial, and Commercial Uses.*"
- Under the subheading "*For control of Bedbugs and Bedbug eggs*"
 - Add "*In difficult to treat areas, a minimum treatment time of 72 hours will provide better results*" after the first sentence ("*...to product vapors for 48 hours*").
 - Revise the directions for use so that any direction or precaution that is necessary to achieve effective, safe use of the product is stated in mandatory terms (e.g.,


revise "Infested items should be placed..." to read "Place infested items..."; "...items should be sealed" to read "...seal items..."; "...treated items should be removed..." to read "...remove treated items..." etc.).

- On page 6, add the following statements after the sentence "Do not use in food/feed processing...service establishments": "Food/feed areas of these establishments where the product is not permitted for use are areas for receiving, storing, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) of food. Serving areas where food is exposed and the facility is in operation are also considered food areas."
- On page 6, revise the statements under the heading "Where to use" as follows: "For use in the following unoccupied structures: vacation homes, ranch houses....and boats provided they are unoccupied for more...."
- The container disposal statements for pesticides have been revised. Refer to PR Notice 2007-4 and modify your label accordingly.
- Additional data are needed to fully quantify the study application rate. Conditional data demonstrating the weight of a 0.24" X 0.39" X 0.21" piece of the strip are required. Submit the data within 3 months of this notice. Please refer to the enclosed Efficacy Review Memo for details.

Please note that a notice of availability of EPA's interim reregistration eligibility document (IRED) for products containing dichlorvos was published in the FR on June 30, 2006 (Vol 71 no. 126 pg. 37568). Additional data and/or labeling changes may be required for products containing dichlorvos.

Garbage Cans, Trash Dumpsters and Trash Receptacles

For control of flying and crawling pests, place the appropriate number of Pro-Strips within the trash receptacles such as compactors, garbage chutes, garbage rooms, garbage bins, and others. Pro-Strip provides control of pests within trash receptacles for up to four months.

Animal Buildings Occupied by People for Less than 4 Hours Per Day

Remove from sealed bag and hang or stand, out of reach of children and pets, in an open space of an enclosed area, away from windows. One (80) 65 g strip will treat 900-1200 cu. ft. which is about equal to an average room 10' x 13' with an 8-foot ceiling for up to four (4) months. In a larger room if more than one strip is required, keep them at least 10 feet apart. Record the date of installation so that the old strip may be replaced with a new, fresh, full strength strip at the end of the four (4) month period or when effectiveness diminishes.
