The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. HOW IT WORKS: This product utilizes controlled release technology to slowly diffuse a deep penetrating vapor in enclosed spaces for up to four (4) months. The clean, odorless vapor is evenly distributed throughout the enclosed treatment area, killing visible and hidden insects on contact and preventing new insect infestations [while you're away].

This product may be used in unoccupied areas and other areas that are occupied for less than four (4) hours per day including garages, sheds, attics, enclosed crawl spaces, museums, museum collections, reptile houses, terrariums, animal buildings, barns, milk rooms, storage units, storage bins, garbage cans with lids, trash bins, trash dumpsters, bulk raw grain bins, grain shipping containers, drop ceilings, mausoleums, enclosed shipping containers/trailers, enclosed utility boxes, vacation homes, cabins, out-houses, mobile homes, recreational vehicles, transportation vehicles,

including cars, trucks, vans, buses, and train and trolley cars (for bed bug control only – see bed bug control section of this label), boats, boathouses, farm houses, ranch houses, catch basins and food serving areas that are not in operation and have no exposed food.

This product may be used in serving areas that are not in operation and have no exposed food. Product may also be used in areas where non-perishable packaged, bagged or bulk raw and processed agricultural commodities (including corn, soybeans, grains, cocoa beans, and peanuts) are stored. Non-food/feed areas of these establishments where the product CAN be used are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and product storage (after canning or bottling).

HOUSEHOLD, INDUSTRIAL AND COMMERCIAL USES

For use in the Following Unoccupied Areas/Structures: Vacation Homes, Ranch Houses, Farm Houses, Cabins, Mobile Homes, Storage Units, Boathouses and Boats provided they are unoccupied for more than four (4) months immediately following placement of product. This product is NOT for Use Within Occupied Homes Except in Garages, Attics, Enclosed Crawl Spaces and Sheds that are occupied for less than four (4) hours per day, or when specifically following the bed bug control use directions listed on this label for treatment of bed bugs.

This product kills flies, mosquitoes, gnats and other listed insect pests for up to four (4) months. Wearing gloves, remove the product from sealed bag when ready to use and place it in provided holder if treatment area is routinely accessed by people or pets. Do NOT allow children to handle new or used product. [Hang] [or] [Place] out of reach of children and pets in an open space of an enclosed area, away from windows. [Hang] [or] [place] the product as high as possible/reasonable within the treated volume of space. Ensure that product does not contact clothes, fabrics or other items and that air can circulate around the product. Calculate cu ft of air space to determine the number of product units required for treatment. One unit will treat 900 to 1,200 cu ft. When multiple product units are required, distribute them uniformly within the treated space. Keep the treated space closed to contain product vapors. Record the date of installation so that the old product may be replaced with a new one at the end of the four (4) month period or when effectiveness diminishes. Do NOT use more than the number of product units recommended for the space to be treated. Do NOT use in any area where people will be for more than four (4) hours per day. Do NOT use in closets and wardrobes of hospital rooms or clinic rooms, such as patient rooms, wards, nurseries, operating or emergency areas where infants, children and the sick or aged are or will be present for more than four (4) hours per day. Do NOT use where unwrapped food is stored or allow the product to come into contact with food or cooking utensils. Do NOT allow children or pets to play or sleep in these areas when treatment is in progress. Do NOT allow children to handle new or used product.

Garbage Cans With Lids, Trash Dumpsters and Trash Receptacles

For control of flying and crawling pests, place the appropriate number of product units within trash receptacles such as compactors, garbage chutes, garbage rooms, garbage bins and others. This product provides control of listed insect pests within trash receptacles for up to four (4) months. Do NOT use in any area where people will be for more than four (4) hours per day.

Animal Buildings

Use this product to control listed insect pests in animal buildings including stalls, barns, milk rooms, kennels, pens, poultry houses, manure storage and other such areas. Do NOT contaminate milk or milking equipment by direct contact with product. Place product in manure collection areas such as beneath egg layers and broilers but do NOT allow product to be placed in areas directly occupied by poultry. Place the appropriate number of product units for the space to be treated. Product provides control of listed insect pests for up to four (4) months. Do NOT use in any area where people will be for more than four (4) hours per day.

Milk Rooms

This product controls flies, mosquitoes and gnats in milk rooms and bulk storage rooms. Do NOT contaminate milk or milking equipment by direct contact with product. Do NOT use in any area where people will be for more than four (4) hours per day.

Agricultural Commodities

This product controls listed stored product insect pests [including] [almond moths] [and] [cocoa moths] [and] [Indianmeal moths] [and] [Mediterranean flour moths] infesting non-perishable packaged and bagged or bulk-stored processed and raw agricultural commodities (such as soybeans, corn, grains, cocoa beans and peanuts). Do NOT contaminate foods. Do NOT allow this product to contact foods. Calculate the cubic feet of air space above the commodity to determine the number of product units required for treatment. One unit will treat 900 to 1,200 cu ft. Treat before moths emerge. Replace product when needed to prevent egg laying by moths. Hang product so as not to impede air circulation. When multiple product units are required, distribute them uniformly over the treated space. Product will control pests for up to four (4) months. Do NOT use in any area where people will be for more than four (4) hours per day.

Catch Basins

To control mosquitoes breeding in catch basins, suspend product about ten inches above the water level. Product may control mosquitoes for 10 to 15 weeks. Do NOT use in any area where people will be for more than four (4) hours per day.

Enclosed Utility Boxes

This product controls mosquitoes and other listed insect pests which commonly infest utility enclosures, cabinets, conduits, junction boxes, enclosed electrical panels, motor control rooms and other utility equipment for communications, electric, gas, water and cable television. Place product so that air can contact all sides of the product. Record installation date and replace when effectiveness diminishes. Do NOT use in any area where people will be for more than four (4) hours per day.

Reptile Houses and Terrariums

Use product to control mites on reptiles and other listed insect pests in reptile enclosures, displays, reptile houses and terrariums. In reptile houses, hang the appropriate number of product units for the space to be treated to provide proper control. Do NOT over-treat. In terrariums, cover the top of an open terrarium having a minimum size of 10 cu ft with a wire screen and place the product on the screen for no more than 48 hours. Product is NOT for treatment of aviaries or birdcages. Do NOT use in any area where people will be for more than four (4) hours per day.

Museum Collections

Use product to protect museum collections and other similar materials from damaging pests when this is a concern. Place product in close proximity or within collection boxes using care to avoid contact with collectible and valuable items. Do NOT use in any area where people will be for more than four (4) hours per day.

For Control of Bed Bugs and Bed Bug Eggs

Product may be used to control bed bug nymphs and adults exposed to product vapors for 48 hours. In difficult to treat areas, a minimum treatment time of 72 hours will provide better results. To kill bed bug eggs, confine vapors in the treated space for seven (7) days.

Product may be used to control bed bugs that have entered various items in an infested structure, including, electronics, small appliances, footwear, artwork, collectibles, plush toys, clocks, radios, wall hangings, telephones, computers, printers, mattresses, box springs, books, lamps, furniture and other such items. Take care to avoid direct contact of the product with the surface of items being treated.

Place infested items in a suitable plastic bag that is completely sealed using tape, twist ties or other means, poly sheeting that is completely sealed by adhesive tape on all sides, container or room that is closed and sealed off to contain the product treatment. Plastic bags or poly sheeting must be at least 2 mils thick. Any mattress or box springs to be treated must be fully enclosed with a single product unit within a large plastic bag or within poly sheeting with all edges taped closed. Seal plastic bags and poly sheeting with as much air space around the treated article as is practical as this will enhance the exposure to the product vapors. Proper seal can be attained by any appropriate manner such as the use of tape, twist ties or other means. Do NOT sleep or lay on mattress while in treatment bag. The closed volume for treatment should not exceed the volume to be treated for the size of the unit used. Professionals should test for adequate seal by testing for the escape of air from the sealed bag. Identify sealed treatment by a label indicating a pesticide treatment is in process that should not be disturbed by unauthorized persons. The label must include the date, and the pest professional person or company responsible and a contact telephone number. When treatment is complete, remove treated items from the treatment in a well-ventilated area and air out for a period of not less than two (2) hours. Discard plastic treatment bag or treatment poly sheeting and used product in trash.

When an unoccupied room is properly closed and sealed to contain the product vapors, it may be located in a home, apartment, hotel, motel, school or other residential, commercial or industrial building. Identify sealed treatment by a label indicating a pesticide treatment is in process that should not be disturbed by unauthorized persons. The label should include the date, and the pest professional person or company responsible and contact telephone number. When a room treatment is completed, the product must be removed and discarded in trash. The room must be thoroughly ventilated for a period of not less than two (2) hours before it is re-occupied.

Product may be used to control bed bugs in transportation vehicles, including cars, trucks, vans, emergency vehicles, buses and train and trolley cars. **Vehicles must not be used during the bed bug treatment.** Place the appropriate number of product units in a vehicle that is then closed/sealed to contain the product vapors. The product must remain in place for 72 hours to control bed bug nymphs and adults and for one week to control bed bug eggs. The ambient temperature should be at least 60° F during the treatment. Identify the vehicle by a label indicating a pesticide treatment is in process that must not be disturbed by unauthorized persons. The label must include the date, and the pest professional person or company responsible and a contact telephone number. When the treatment is complete, remove the product in a well-ventilated area and thoroughly ventilate the vehicle for a period of not less than two (2) hours.
