  - g) Revise the container disposal statement so that it is consistent with the criteria for container disposal under PR Notice 2007-4.
3. Generate and submit the results of an one year storage stability and corrosion characteristics study to the Agency on completion. It is recommended that the observations be made at 0, 3, 6, 9, and 12 months intervals.
