### Dear Ms. Porter:

The amended label referred to above, submitted in connection with reregistration of dazomet under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following label revisions are made and the following conditions are met:

#### LABEL REVISION

- 1. On page 2, under "Directions for Use," third paragraph starting with "Application with handheld...." is applicable to enduse products only. This statement may be remove from the technical label.
- 2. On page 2, under "Directions for Use," fifth paragraph, starting with "at the point...." remove the additional spacing between words.

#### CONDITIONS

1. EPA has determined that the risk mitigation measures on the revised label for this product are necessary to adequately protect human health and the environment. Therefore, pursuant to 40 CFR § 152.130(d), EPA has decided that no product bearing previously approved labeling may be sold or distributed (released for shipment) by its registrant after December 1, 2012. Wherever state approval is required for sale or distribution of this product with this new labeling, EPA strongly encourages you to submit an application to the state authority as soon as possible. You should be aware that the Agency does not intend to modify the December 1, 2012, deadline because of any failure to obtain state approvals.

2. Submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

# PRECAUTIONARY STATEMENTS

## HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**WARNING:** May be fatal if swallowed. Prolonged contact may cause irritation of skin, eyes and mucous membranes. Do not breathe dust. Avoid contact with skin, eyes and clothing. Wash hands thoroughly after contact.

#### **ENVIRONMENTAL HAZARDS**

This pesticide is toxic to fish and aquatic invertebrates. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance, contact your State Water Board or Regional Office of the Environmental Protection Agency.

#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Only for formulation into a fumigant for the following use(s): golf courses (greens, tees, fairways), nonbearing crops, turf sites, ornamental sites, field nurseries, greenhouses, compost piles, potting soils, and strawberries and tomatoes in California only.

Application with handheld equipment is prohibited. End use products with directions for use for soil fumigation must specifically prohibit these uses and all references to such applications must be removed.

Dazomet cannot be formulated into end-use products labeled for pre-plant or pre-transplant uses unless the end-use registrant makes available to certified applicators who purchase or apply the end-use product a registrant developed training program approved by EPA. The training program must provide information on (1) how to correctly apply the fumigant, including how to comply with new label requirements; (2) how to protect handlers and bystanders; (3) how to determine buffer zone distances; (4) how to complete an FMP and the post-application summary; (5) how to determine when weather and other site-specific factors are not favorable for fumigant application; (6) how to comply with required GAPs and how to document compliance with GAPs in the FMP; and (7) how to develop and implement emergency response plans. The registrant developed training program must be made available at least annually to the certified applicators. The end-use registrant must be able to provide, upon request, the names, addresses, and certified applicator license and/or certificate number of persons who successfully complete the registrant developed training program.

Dazomet cannot be formulated into end-use products labeled for pre-plant or pre-transplant uses unless the end-use registrant assures Buffer Zone signs suitable for posting buffer zones or templates for the buffer zone signs are available to its downstream distributors/customers who in turn will provide the signs at the point of sale. The Buffer Zone sign must meet the following standards:

• Signs must remain legible during the entire posting period, and must meet the general standards outlined in the WPS for sign size, text size, and legibility (see 40 CFR §170.120).

This product may be used to formulate products for any additional use(s) not listed on the MUP label if the formulator, user group, or grower has complied with U.S. EPA submission requirements regarding support of such use(s).

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store this product in a dry, cool place below 95°F. Material reacts non-violently with moisture releasing fumigant vapors. Keep container tightly sealed when not in use. Do not reuse empty container. Keep this product and its vapors away from desirable plants, seeds, fertilizers, insecticides and other agricultural chemicals as plant injury may result from contamination.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

#### **CONTAINER HANDLING:**

**Bag:** Nonrefillable container: Do not reuse or refill this container. Completely empty bag into application equipment. Then offer for recycling, if available, or dispose of bag in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

**Fiber (Box) Drum:** Nonrefillable container: Do not reuse or refill this container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then offer for recycling, if available, or dispose of liner in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke. If (box) drum is contaminated and cannot be reused, dispose of in the same manner.

Plastic Container (greater than 50lbs): Nonrefillable container: Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container <sup>1</sup>/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling, if available, or reconditioning, or puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke

Plastic Container (equal to or less than 50 lbs): Nonrefillable container: Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/2 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling, if available, or reconditioning, or puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by State and local authorities for burning. If burned, stay out of smoke.
