

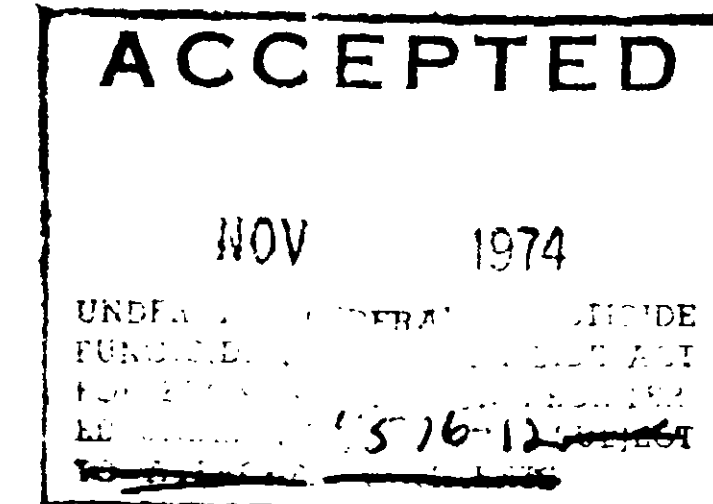

Where no facilities are available to indicate a reduction to less than 50 ppm available chlorine in sanitizing solution by use, then start with 200 ppm available chlorine solution. (4-ounces of this product in 6 gallons water.)

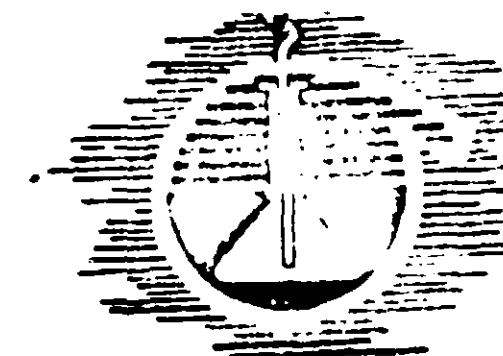

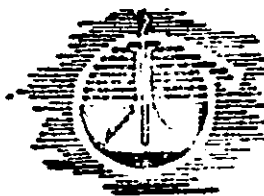
