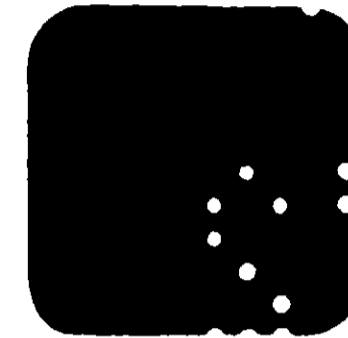

DIRECTIONS FOR USE

To make a 0.3% Lindane residual spray for the insects indicated below, use 1 gallon Lindane 20% Solution in 88 gallons of odorless kerosene weighing 6.5 pounds per gallon.

HOUSE FLIES, MOSQUITOES AND GNATS: INDOORS: Thoroughly and repeatedly treat doors, around windows and areas frequented by these insects. **OUTDOORS:** To prevent entry to these insects into human dwellings, thoroughly treat screens, window frames, door sills and selected areas of porches where these insects tend to alight or congregate. Repeat applications as necessary to obtain the maximum value against these pests since insecticidal residues on the outside of buildings tend to deteriorate quite rapidly.

ROACHES, SILVERFISH AND SPIDERS: Spray on insects directly when possible and thoroughly treat infested cracks and crevices in woodwork, dark places behind pipes and other hiding or resting places. Repeat application as often as necessary to maintain effective control.

ANTS: Spray into cracks and other hiding places and hit pests directly when possible. Be sure to treat ant trails and areas around door sills and window frames, where the pests enter the premises. It is frequently desirable to treat the openings around water pipes, heat ducts, electrical outlets and baseboards where ants come into rooms from wall spaces and partitions. Application should be repeated as often as necessary to maintain effective control.

CLOTHES MOTHS: Spray thoroughly all articles to be protected, paying particular attention to seams and folds. Spray thoroughly all closets, trunks and other storage containers. Repeat application monthly, unless treated articles are in a moth-tight container. All articles should be dry cleaned before allowing them to be used as clothing or as bedding.

TO PREVENT CRYSTALLIZATION, DO NOT STORE AT TEMPERATURES BELOW 50° F.
