## DIRECTIONS

Thoroughly mix one part by weight of PIVALYL CONCENTRATE with 19 parts by weight of a suitable bait material such as oat meal, corn meal, cracked corn, etc.

For increased palatability and to facilitate the preparation of baits, corn, peanut or mineral oil up to 5% and sugar up to 5% may be substituted for equivalent amounts of the bait material.

For top efficiency baits should be placed in areas where rats and mice have been observed feeding. Baits should be placed in locations inaccessible to cats, dogs, livestock and poultry.

**RATS:** Bait in the amounts from ¼ to ½ pound. An uninterrupted supply of bait should be maintained for at least 10 days.


MICE: Bait should be reduced to tablespoonful quantities but more bait stations should be used. An uninterrupted supply of bait should be maintained for at least 15 days.

For maximum results baiting should be maintained as long as infestation persists and rodents continue to feed. Permanent bait stations suitably serviced should be used where reinfestation is possible.

**NOTE:** Bait stations should be checked regularly and refilled before empty. Baits containing PIVALYL CONCENTRATE have excellent keeping qualities and are highly acceptable to rats and mice. If baits are moldy, soured, or infested with insects, they should be replaced.

2. Rat droppings, 3/8 to 1/2 inch long, oval in shape. Shiny black droppings are an indication that they have been recently deposited.


