DIRECTIONS FOR USE

Kills the Accessible stages of INDIAN MEAL MOTH, DRIED FRUIT BEETLE, and CONFUSED FLOUR BEETLE in dried fruit products storage areas or processing areas. Close room or warehouse and shut off all ventilating systems. Use a spraying device similar to the MICRO-GEN equipment to dispense this product. Do not apply to dried fruit directly. Direct spray into areas of the room frequented by these insects hitting as many insects as possible. Then spray into the air above the trays at a rate of ½ gallon of spray per 50,000 cubic feet of space. Repeat application every 30 days. Leave room closed for one hour after application. Do not remain in treated areas and ventilate before re-entry. Infested stored dried fruit should be furnigated or treated by other effective methods using an approved product intended for this purpose.

Kills the Accessible stages of RICE WEEVIL, YELLOW MEALWORM CADELLE, CONFUSED FLOUR BEETLE, SAW-TOOTHED GRAIN BEETLE, ANGOUMOIS GRAIN MOTH, MEDITERRANEAN FLOUR MOTH, and INDIAN MEAL MOTH in food ware house, storage rooms and similar areas. Close room or warehouse and shut off all ventilating systems. Use a spraying device similar to the MICRO-GEN equipment. Direct spray into corners, under pallets and around stacks of packaged goods. Hitting as many insects as possible. Then spray at the rate of one fluid ounce of spray per 1,000 cubic feet of space. Repeat applications as necessary. Leave room closed for one hour after application. Do not remain in treated areas and ventilate prior to re-entry. Infested package goods should be fumigated or treated by other effective means using an approved product intended for this purpose.

To kill ROACHES, SILVERFISH, EARWIGS, ANTS, and SPIDERS. Apply in MICRO-GEN or similar equipment adjusted to coarse spray. Apply the spray into all cracks and crevices in woodwork, walls, floors, underneath sinks, behind pipes, and in all places where these insects hide. Contact as many insects as possible. Do not allow spray to contact stored food. Repeat treatment as necessary for control.

To kill FLIES, MOSQUITOES and GNATS in open areas, dilute concentrate with petroleum distillate at the rate of one part concentrate to two parts oil and mix well. Use at a time when the temperature is cool (75°F or less) and the wind velocity is approximately 5 mph. With equipment similar to the MICRO-GEN equipment, spray at a dosage rate of 15 ounces per minute upwind of the area to be controlled.

If the equipment is truck mounted, keep the speed at approximately 5 mph and treat a swath width of no more than 300 feet.


