

**GENERAL DIRECTIONS**

Place Hub States No. 147 in locations where rats and mice feed, water, and travel.

Bait placements along walls, in corners, and in concealed locations where rats and mice can feed unobserved are desirable.

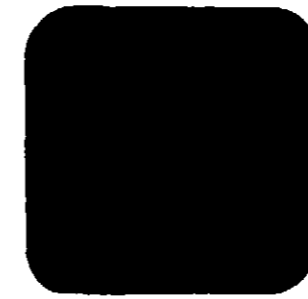
Contaminated or spoiled baits should be replaced promptly.

Where a continuous source of infestation is present (nearby dumps) permanent bait stations should be established and the bait replenished as needed.

Treated baits should be placed in locations not accessible to children, pets, wild-life and domestic animals, or in tamper-proof bait boxes.

**DIRECTIONS FOR RAT CONTROL:** Place (4 to 16 ozs.) of bait per placement. An uninterrupted supply of Hub States No. 147 should be maintained for at least 10 days.

**DIRECTIONS FOR MOUSE CONTROL:** Tablespoon amounts (1/4 to 1/2 oz.) of Hub States No. 147 should be placed 8 to 12 foot intervals. An uninterrupted supply of bait should be maintained for at least 15 days.

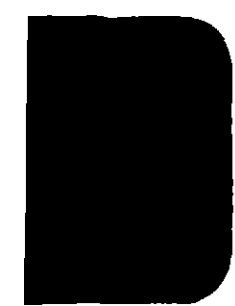
