
## CONDITIONS OF SALE - LIMITED WARRANTY AND LIMITATIONS OF LIABILITY AND REMEDIES

Subject: Updated Product Labeling Submitted with Your Letter Dated June 5, 1990 EPA Registration No. 5602-176

The labeling referred to above, submitted in connection with registration under the section 3(c)(7)(A) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the following comments:

1. Petroleum distillates are listed as an active ingredient in the label whereas they are listed for use as a solvent in the Confidential Statement of Formula. Therefore, you should either report petroleum distillates as an inert ingredient with a footnote to the ingredient statement indicating "Contains petroleum distillates," or provide the EPA Registration Number for the source product and justify its insecticidal properties.
