**STATEMENT OF PRACTICAL  
TREATMENT**

Under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, for the pesticide registered under EPA Reg. 5602-202

**FLIES, MOSQUITOES, GNATS, WASPS, HORNETS, SANDFLIES, AND SMALL FLYING MOTHS:** Ascertain the cubic feet of space to be treated. Close doors and windows. Pointing nozzle upward, direct the aerosol mist to all parts of the room especially around window frames and other light sources which attract these insects. Keep nozzle in continuous motion at least 36 inches from fabrics. Apply for one second per 1000 cubic feet of space. Keep area closed for fifteen minutes after each treatment. Do not remain in treated area, ventilate the area after treatment is completed. Swoop up and destroy fallen insects. Repeat treatment as necessary.
