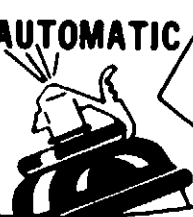

GENERAL DIRECTIONS

Close doors and windows and turn off fans and air conditioners. Remove pets. Cover exposed foods, utensils, and food handling surfaces. Product can be used around food and utensils if they are protected from direct contact while spraying. Open cabinets and doors to expose spaces to be treated. Extinguish all flames, except pilot lights and release can at least 6 feet away from pilot lights. For best results leave treated space undisturbed for two hours or more. After treatment open doors and windows and allow to ventilate for 30 minutes.

AS A TOTAL RELEASE AEROSOL

DIRECTIONS: Holding container upright and away from you tilt sprayhead until tip engages rim of valve mounting cup. Valve will remain in open position for total release of contents. Place in upright position in an elevated location (if possible) such as on stand or table. Place paper under can to protect surface immediately around area of release.

Release the contents of this can for each 13,000 cubic feet of unobstructed space. The additional units for remote areas or where free flow of fog is not assured.

AS AN AEROSOL INSECTICIDE

To kill ~~flies~~ *flies*, ~~wasps~~ *wasps*, ~~crickets~~ *crickets*, ~~ants~~ *ants*, ~~moths~~ *moths*, ~~waterbugs~~ *waterbugs*, ~~silverfish~~ *silverfish*. Close all doors and windows and direct spray into center of room with slow sweeping motion. Spray 5 to 10 seconds for average room. Keep nozzle three feet from surfaces. Keep room closed for 15 minutes after spraying.

To kill roaches, waterbugs, silverfish, crickets, ants. Spray baseboards, cracks, crevices, moist areas, and openings around sinks and pipes and other hiding places, hitting insects directly. Spray ant hills and ant trails over window and door sills and other locations. Repeat as necessary for control.

To kill fleas: Spray floor coverings and sleeping quarters of pets. Repeat as necessary.
