Spa-Care Algaecide-60
Concentrate

is used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and hot tubs. Heavy growth of algae should be cleared prior to using.

For pools having just visible algae growth add an initial dose of 6 fluid ounces of Spa-Care Algaecide-60 Concentrate per 10,000 gallons of water. Subsequent additions of 11 fluid ounces of Spa-Care Algaecide-60 Concentrate per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 1 to 2 fluid ounces per 1000 gallons of water. For treatment of a freshly installed hot tub or decorative fountain, add initially 0.2 fluid ounces of Spa-Care Algaecide-60 Concentrate per 1,000 gallons of water.

Spa-Care Algaecide-60 Concentrate should be made every 5 to 7 days after initial treatment. Spa-Care Algaecide-60 Concentrate is compatible with chlorine products used to treat pools, spas, and decorative fountains. Maintain a pH of 7.2 to 7.6. Spa-Care Algaecide-60 Concentrate is compatible with decorative fountains treated with chlorine chemicals or chemicals normally required. However, do not mix Spa-Care Algaecide-60 Concentrate with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept out of reach of children and away from food.

DISPOSAL: Do not reuse empty container. Wipe out container with water.
