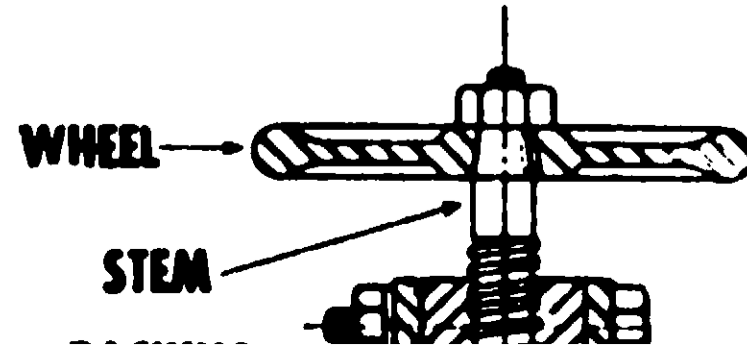

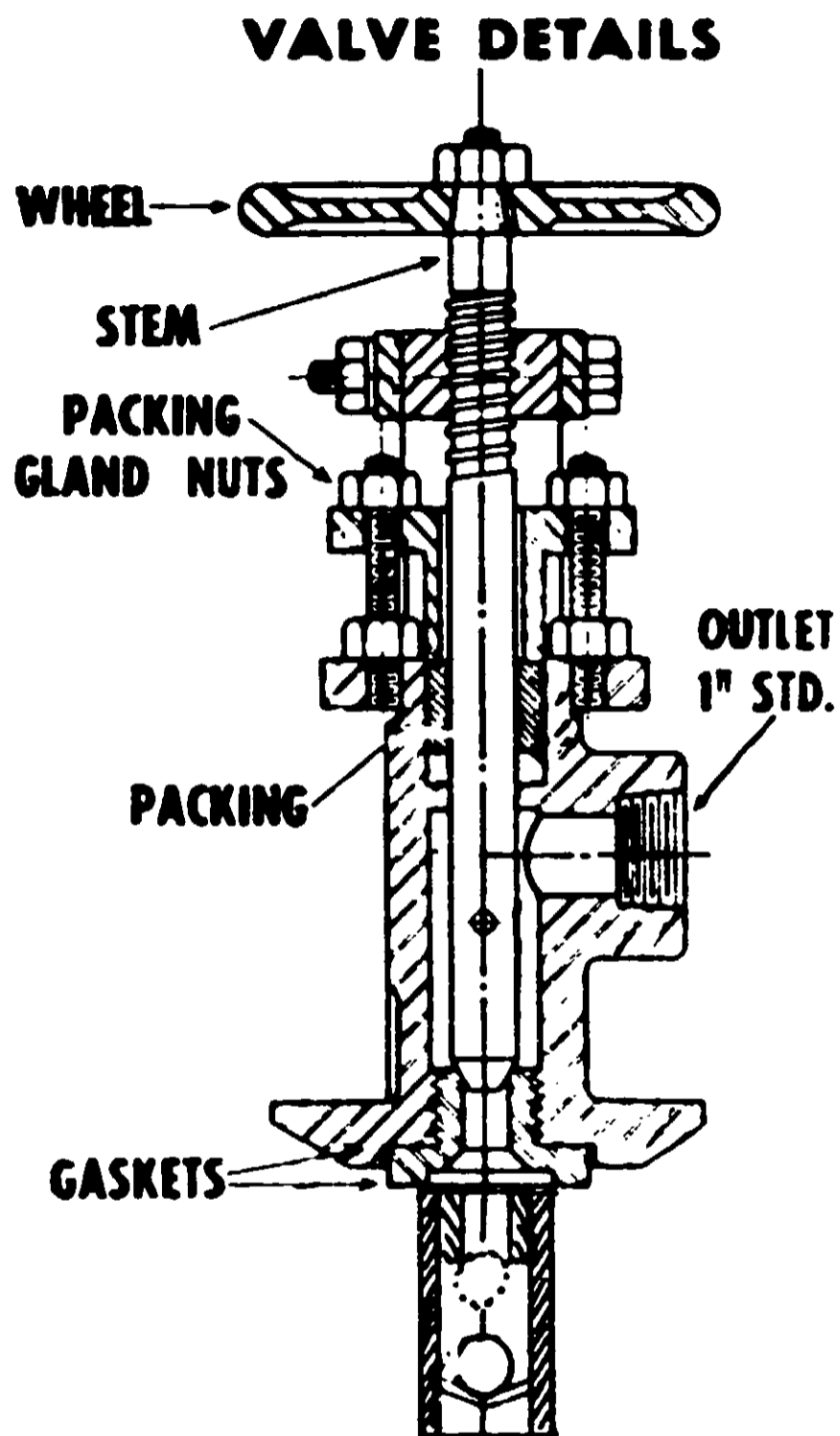
VALVE DETAILS



LIQUID CHLORINE OUTLET VALVE

1. Before opening valve, be sure packing gland nuts are snug. Check during use, tightening if necessary to prevent leakage.

LIQUID CHLORINE OUTLET VALVE

1. Before opening valve, be sure packing gland nuts are snug. Check during use, tightening if necessary to prevent leakage.
2. Check all connections for leaks, using ammonia.
3. Be sure valve is closed before removing outlet plugs.
4. Use an expansion loop between valve and unloading line.
5. Reduce pressure to under 100 lbs. before disconnecting.
6. When empty, close all valves and replace all plugs before releasing car.
7. The ball check valve, installed below the liquid valve, closes when there is a sudden surge of liquid in the line as might occur in case of a break, or if the liquid valve is opened too quickly. To release the ball to its open position, close the liquid valve and tap the manway plate.

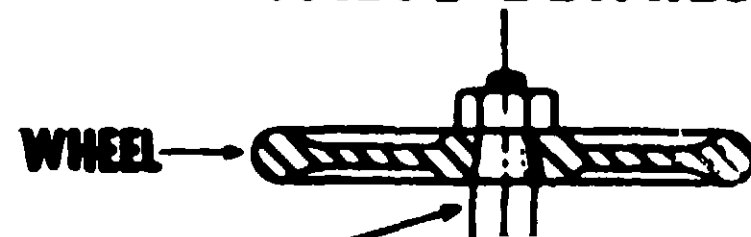

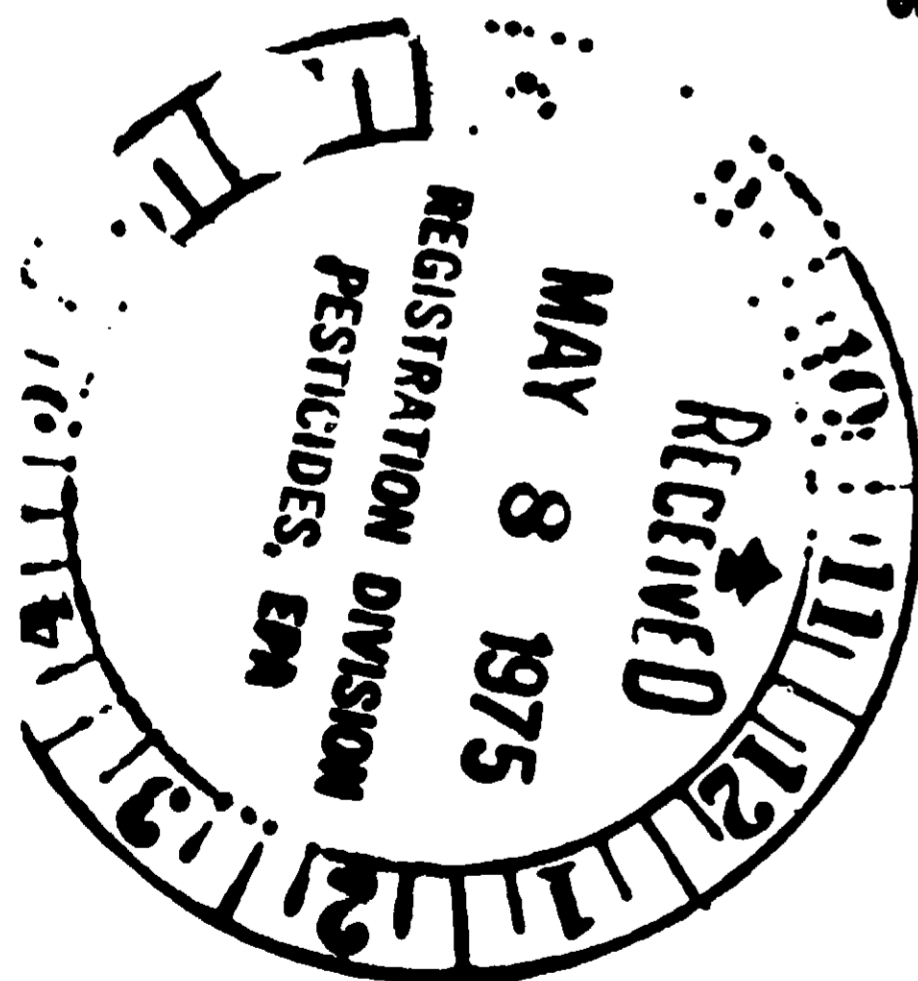
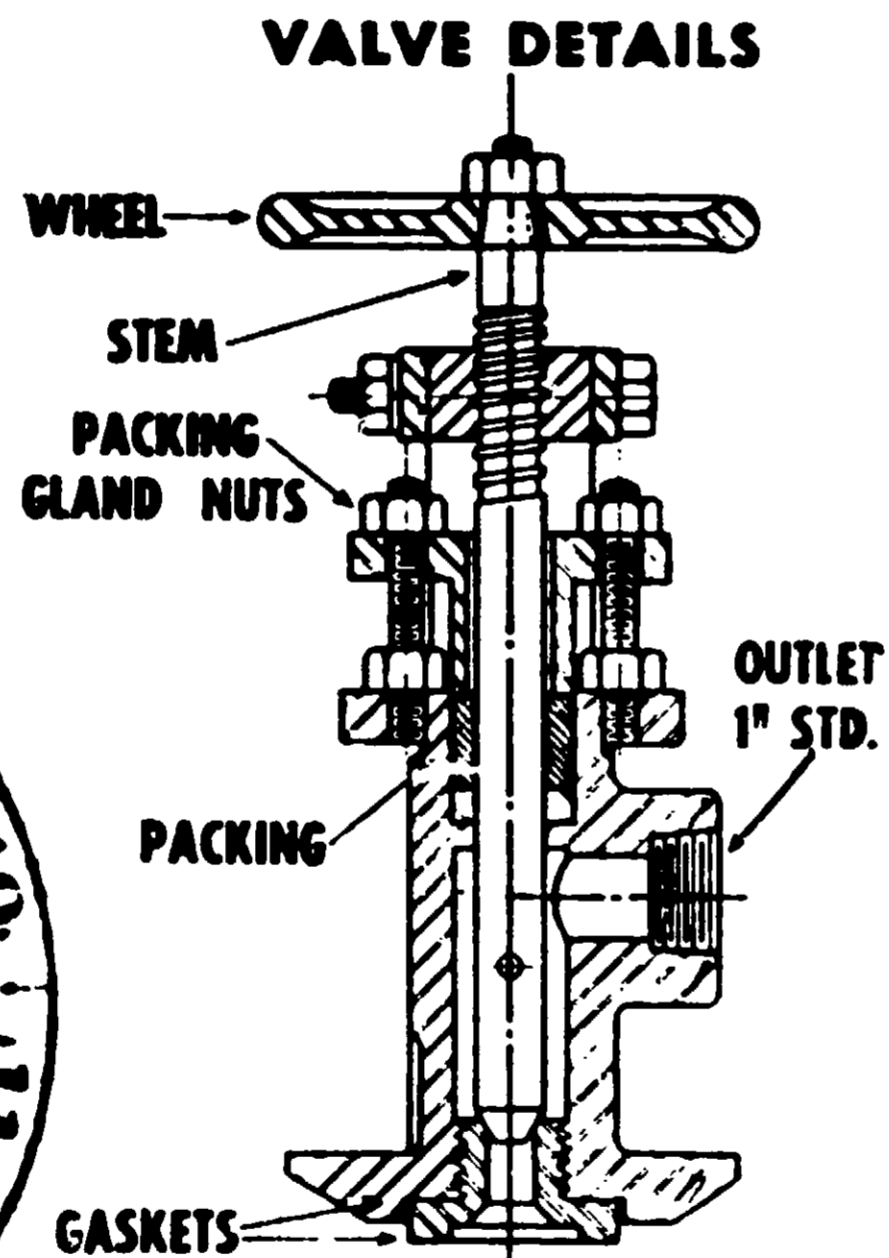

CHLORINE GAS OUTLET VALVE TO MAKE CONNECTIONS

1. Be sure that valve is closed.
2. Remove outlet plug
3. Connect to outlet using 1-inch standard pipe.
4. Inspect valve and connections frequently. Tighten packing glands when necessary.
5. Return cars with all valves closed and outlet plugs in place.

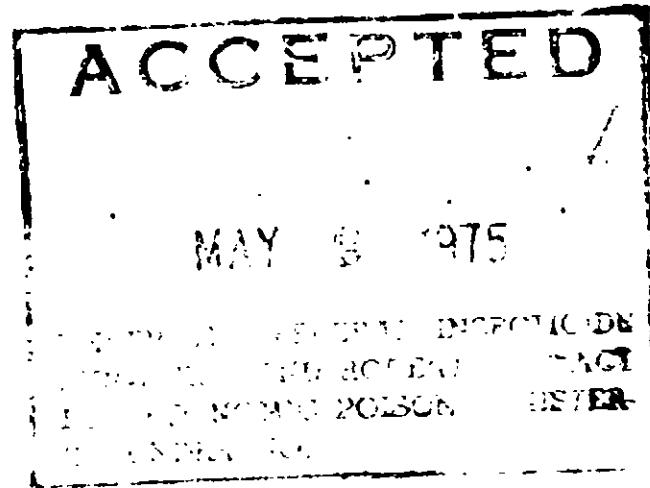
