#### DIRECTIONS

TO KILL ROACHES AND WATER BUGS: Apply in all cracks and crevices in woodwork, underneath sinks, dark places, behind pipes, and in all places where roaches and water bugs infest. Repeat as often as necessary.

TO KILL CLOTHES MOTHS, CARPET BEETLES: Spray all articles to be protected, giving particular attention to folds and seams. Interior surfaces of storage containers such as closets, chests and trunks should be regularly sprayed. Repeat every thirty days.

TO KILL ANTS: Use the spray so as to wet as many insects as possible, paying particular attention to nests or runways. Repeat treatment as often as necessary.

TO KILL FLIES, MOSQUITOES AND GNATS: Close room and discharge spray mist vigorously in all parts of room, using about 2 or 3 ounces for each 1000 cubic feet of space. Leave room closed for at least ten minutes. Sweep up and destroy fallen insects. Repeat as needed.

TO KILL FLEAS (Infesting Premises): Remove and destroy <u>animals' bedding</u> and spray <u>sleeping quarters</u> freely, forcing the spray into all <u>cracks</u> and about the room. Repeat when re-infested.

TO KILL GRAIN WEEVILS, Cadelles, Grain Moths, Flour Beetles and Grain Mites (Accessible Stages): Wet surfaces throughly and treat all infested surface areas, insect hiding places and insect runways at the rate of 1 gallon of this material on 750 square feet of area, equivalent to spraying to the point of run-off. Repeat when necessary. For Flying Moths and Beetles, treat as for Elies, Mosquitoes and Gnats (see above).

This formulation is especially designed for use in dairies, bottling plants, restaurants, food storage warehouses, meat packing plants and the like.

## **CAUTION**

#### KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Do not apply directly to food. Cover or remove all food and food processing equipment during application. Do not apply while food processing is underway. After spraying in meat packing plants, bakeries and other food processing plants, wash with potable water all equipment, benches shelving, etc. where exposed food will be handled. In case washing is impractical, do not allow food to come in contact with treated surfaces for at least 48 hours. Remove bird cages and fish bowls during spray application. Do not store, pour or spill near heat or open flame. Keep container closed.
