

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

in swimming pools, exterior spas, whirlpools, hot tubs, innum effectiveness pools, spas, whirlpools, hot tubs, heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial dose of 4 fluid ounces of Puricide Pool&Spa Algae, move settled algae debris by cleaning. For treatment of a pool add initially 41 to 75 fluid ounces of Puricide Pool&Spa Alg. per 10,000 gallons of water. Subsequent additions of Puricide Pool&Spa Alg. per 10,000 gallons 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly hot tub, or decorative fountain, add initially 4 Puricide Pool&Spa Algaecide per 1,000 gallons of 1 to 3 fluid ounces of Puricide Pool&Spa Algaecide should be made every 5 to 7 days after initial treatment.

Puricide Pool&Spa Algaecide is compared to treat pools, spas, and decorative fountains with an alkaline pH. Puricide Pool&Spa Algaecide is compared to decorative fountains treated with chlorine chemicals or chemicals normally required. However, do not mix Puricide Pool&Spa Algaecide with concentrated dry or liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty container. Use only as directed.
