Spray surfaces regularly in all areas where bacteria grow and odors occur. Bathrooms, hampers, sinks, toilet seats, diaper containers, garbage cans, pet areas and areas prone to dampness such as cellars, attics and closets; also telephones, doors and much-handled objects.

On Environmental Surfaces:

- Kills many dangerous germs, such as Pseudomonas aeruginosa, Streptococcus pyogenes and Staphylococcus aureus.
- Kills odors and odor-producing bacteria.
- Prevents mold and mildew.
- Kills Influenza A-2 Virus.

Shield Disinfectant Spray helps to kill many household germs and removes odors from environmental surfaces, particularly in kitchen, bathrooms and babies' rooms.

**WARNING: FLAMMABLE.** Do not use near flame or store where heat may exceed 120 degrees F. Do not spray on food or utensils. Avoid spraying in eyes. Do not throw in fire or puncture can. Do not spray towards the face. Avoid breathing spray mist. Keep away from children.

**DIRECTIONS:** Hold upright and spray surfaces from 6 inches away until mist forms. To deodorize air, spray towards ceiling in center of room. The treatment of food contact surfaces must be thoroughly scrubbed with detergent and rinsed with potable water prior to reuse.

To control mildew, clean surfaces prior to application. Spray surfaces from 6 inches away until moist and repeat as follows:

- For leather, repeat every 7 days.
- For fabrics, repeat every 14 days.
- For wood, repeat every 7 days.
- For hard surfaces, repeat as necessary.

**ACTIVE INGREDIENTS:** o-phenylphenol 0.1%, diisobutylphenoxyethoxyethyl dimethyl benzyl ammonium chloride 0.272%, ethyl alcohol 60.604%, essential oils 0.2%.
