DIRECTIONS FOR USE

It is a violation of Federal laws to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USE. Point valve away from face and press button. Hold can at least 3 feet from surfaces which may stain and 18 inches from plants.

FOR CONTROL OF PESTS AROUND THE HOME

FLYING INSECTS (Flies, Mosquitoes, Gnats and Moths) – Direct Spray at insects using short bursts (1 to 2 seconds) or treat unoccupied areas as follows: Close doors and windows. With a sweeping motion direct spray upward to all parts of the room (8 to 10 seconds per 1000 cubic feet). Keep room closed for 15 minutes and ventilate before reoccupying.

CRAWLING PESTS (Ants, Boxelder Bugs, Crickets, Earwigs and Sowbugs) – Spray into cracks or woodwork, walls, floors and other hiding and breeding places. Direct spray to contact pests when possible. Spray ant trails and areas around door sills and window frames.

WASPS AND HORNETS – Direct spray at these insects using short bursts. Spray thoroughly into nests, hiding and breeding places when insects have settled at night.

FOR CONTROL OF PESTS ON ORNAMENTAL PLANTS

For control of aphids, two-spotted spider mites and adult white flies on ornamental house and greenhouse plants (African violet, aralia, Christmas cherry, chrysanthemum, cineraria, diffenbachia, fuschia, gloxinia, ivy, lantana, Neanthe bella palm, petunia, rose and snap dragon and on outdoor plants azalea, chrysanthemum, euonymus, ivy, marigold, petunia, rose, snap dragon and zinnia). Spray plants with a slow sweeping motion so that mist drifts into plants. Direct spray so that upper and lower leaf surfaces are contacted. Use caution on new growth and tender foliage. Repeat as necessary. When using outdoors spray when air is still. Do not spray bearing fruit trees.

STATEMENT OF PRACTICE TREATMENT

In case of skin contact wash off with soap and water
In case of ingestion do not induce vomiting. Seek immediate medical attention

WARNING

Avoid breathing of vapor and skin contact. Avoid contact with eyes. In case of contact, flush with water. Do not smoke while spraying. Contents under pressure. Never set containers on stove or radiator or place where temperature will exceed 120°F. Do not spray in areas where food is processed or served. Do not use on or around animals. Cover or remove fish bowls for 1 hour. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before re-use.
