DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Team B "17" Cooling Tower Treatment is used to control algae and bacteria in recirculating commercial and industrial water cooling towers. Prior to its use, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 3.3 to 6.6 fluid ounces of Team B "17" Cooling Tower Treatment per 1000 gallons of water is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.1 to 6.6 fluid ounces of Team B "17" Cooling Tower Treatment per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

PESTICIDE DISPOSAL: Pesticide, spray mixture, or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides, or buried in a safe place away from water supplies.

CONTAINER DISPOSAL:

- METAL: Triple rinse (or equivalent) and offer for recycling, reconditioning, or disposal in an approved landfill or bury in a safe place. Containers over 30 gallons should be resealed before offering for reconditioning.
