CAUTION

Note to Physician Carbaryl is a moderate cholinesterase inhibitor. Atropi s antidotal. Do not administer 2-PAM.

Environmental Hazards

This product is toxic to fish. Do not apply directly to water. Do not apply when runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read label thoroughly. Apply this product only as specified on this label. Apply as a light uniform dust spray to the entire plant surface, especially on the underside of foliage. Apply to soil around the plant. Apply when pests first appear. Repeat as necessary. For best results, dust in early morning or late evening when air is still. ROSES, FLOWERS, SHR"BS, TREES, WOODY PLANTS: To control Japanese or June Beetle; Boxelder, Lace or Tarnished Plant Bug; Mealybugs, Elm Leaf Flea, Pafhoppers, Leaf Rollers, Thrips (exposed), Tent Caterpilla, Cutworms, Earwigs. TOMATO, EGGPLANT, PEPPER: To control Tomato Fruitworm or Hornworm; Lace Stink or Tarmshed Plant Bug; Leafhoppers. Use up to day of harvest. CUCUMBER SQUASH, PUMPKIN, MELON: To control Melonworm, Cucumber or Flea Beetle; Leafhoppers, Squash Bug. Use up to day of harvest.

LETTUCE, CARROT, CABBAGE, BROCCOLI, CAULIFLOWER, BRUSSEL SPROUTS, KOHLRABI, RADISH, BEET, TURNIP: To control Armyworms, Cutworms, Corn Earworm, Flea Beetle, Leafhoppers. Do not apply within 3 days of harvest; 1-day on Carrots. Do not apply within 14 days of harvest on Leaf Lettuce, Spinach and Swiss Chard. Do not treat Beets and Turnips within 14 days of harvest when tops are to be used as food. BEANS, PEAS, CORN: To control Leafhoppers, Grasshoppers, Armyworms, Cutworms; Stink or Tarnished Plant Bug; Japanese, Flea or Cucumber Beetle. Use up to day of harvest. STRAWBERRIES, BOYSENBERRIES, RASPBERRIES, BLACKBERRIES: To control Japanese Beetle, Leaf Rollers, Leafhoppers, Strawberry Weevil. Do not apply within 7 days of harvest; except Strawberries, 1-day. PEACHES, APRICOTS, NECTARINES: To control June Beetle, Leaf Roller Plum Curculio, Codling Moth. Do not apply to Apricots and Nectarines within 3 days of harvest; 1-day on Peaches. CHERRIES, PLUMS, PRUNES: To control Mealy Plum or Black Cherry Aphid; Flum Curculio, Prune Leafhopper, Leaf Roller. Do not apply within 1-day of harvest. APPLES, PEARS, WALNUTS: To control Apple Aphid, Pear Psylla, Codling Moth. Do not apply to Apples and Pears until 30 days after bloom, or 1-day before harvest. FOR USE ON DOGS AND CATS: To control Lice, Fleas, Ticks. Dust liberally over animal and rub thoroughly into skin. For Brown Dog Ticks be sure to also apply on legs, feet and between toes. Comb out dead ticks a few hours after treatment. Keep dust out of eyes. Do not use on puppies or kittens under four weeks of age. IN AND AROUND DOG AND CAT QUARTERS: To control Lice, Fleas, Ticks. Dust liberally in and around sleeping quarters, kennels and dog houses. Force into cracks and crevices. Repeat at weekly intervals or as needed.

STORAGE AND DISPOSAL

Storage: Store in original container in a dry place. Do not contaminate food or feed. Keep out of reach of children.

Disposal: Securely wrap original container in several layers of paper and discard in rash. Do not reuse container.
