Directions for Applying Cutworm & Sowbug Control

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Chacon Cutworm & Sowbug Control is formulated to attract and kill cutworms, sowbugs, earwigs, crickets, darling ground beetles, grasshoppers, millipedes, armyworms and ants coming in contact with the pellets. For use in and around ornamentals, ground covers, lawns, and certain listed vegetables.

ORNAMENTALS, GROUND COVERS, LAWNS: Start treatment at first sign of pest activity. Water area first, then do not water for at least 24 hours. Spread pellets lightly over area. Apply at the rate of 1 1/4 pounds per 1250 sq. ft. Sowbugs and Cutworms feed mainly at night. It is best to put out the pellets in late afternoon or evening. Application should be repeated at 2-week intervals as long as needed.

VEGETABLES LISTED: Apply on the ground and adjacent to plants. Do not apply to EDIBLE PARTS OF THE PLANTS. Broadcast applications may be used when there is a heavy infestation. Repeat applications as necessary. Control will be obtained with 2/3 lbs to 1 1/4 lbs per 1250 sq. ft. of bait. For the control of sowbugs, cutworms, armyworms, earwigs, millipedes and ants.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
