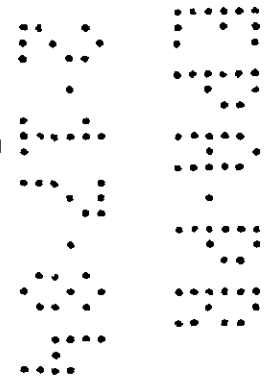

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION

Keep out of reach of children. Harmful if swallowed. Avoid inhalation of dust. Avoid contamination of food or feed. Wear long sleeved shirt during application. Statement of Practical Treatment: If swallowed, induce vomiting. at once. Get medical attention. If inhaled, remove affected person from exposure. If in eyes, flush with fresh water for at least 3 minutes. Get medical attention if irritation persists. If on skin, wash affected area with soap and water. Note to Physician: Carbaryl is a moderate cholinesterase inhibitor. Atropine is antidotal. Do not administer 2-PAM.

Environmental Hazards

This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

Physical or Chemical Hazards

Avoid dispersion of Dust. Avoid contamination with mineral acids or alkalis. Do not use on puppies or kittens under 4 weeks of age.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read the entire label thoroughly. Apply this product only as specified on this label.

SHAKE WELL BEFORE USING - CUT TIP OF SPOUT.

FOR USE ON DOGS AND CATS: To control Lice, Fleas, Ticks. Dust liberally over the animal and rub thoroughly into skin. For Brown Dog Ticks be sure to also apply on legs, feet and between toes. Comb out dead ticks hour after treatment.

Keep dust out of eyes. Do not use on puppies or kittens under 4 weeks of age.

FOR USE IN AND AROUND SLEEPING QUARTERS, KENNELS, AND DOG HOUSES: Force dust into cracks and crevices. Repeat as necessary.

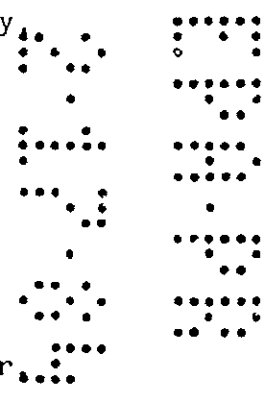
FOR USE INSIDE THE HOME: Sprinkle lightly on furniture, floors and rugs. Remove with a vacuum after 1 or 2 hours.

STORAGE AND DISPOSAL

Storage: Store in original container in a dry place. Do not contaminate food or feed. Keep out of reach of children.
