SHAKE BEFORE USE.

FOR USE ON ORNAMENTAL PLANTS, INDOORS AND OUTDOORS: Peperonia, Spirea, Philodendron, African Violet, Euonymus, Sedum, Ferns, Crabapple, Rose, Wisteria.

FOR INDOOR PLANTS: Spray both upper and lower surface of leaves from a distance of 12-14 inches until visibly wet. Repeat as needed.

FOR OUTDOOR PLANTS: Spray in the evening or on a cloudy day when air is still. Avoid using in hot, bright sunshine. Use slow sweeping motion, holding the dispenser approximately one foot from foliage. Spray both upper and lower leaf surfaces until wet. Repeat as needed.

### STORAGE AND DISPOSAL

Storage: Store in original container in a cool place away from heat or open flame. Keep out of reach of children.

Disposal: Securely wrap original container in several layers of paper and discard in trash. Do not reuse empty container.
