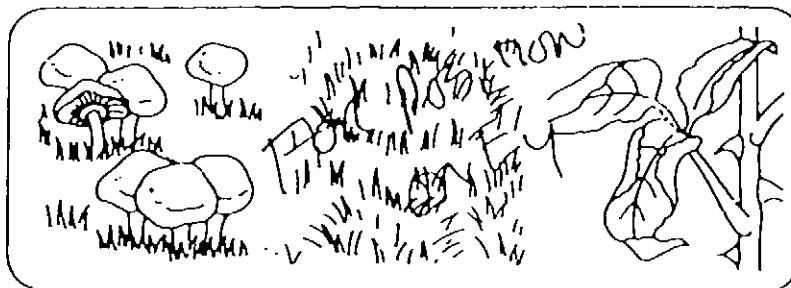

### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. **Read entire label carefully before using.** SHAKE WELL BEFORE USING. KEEP AGITATING TANK OR HOSE-END SPRAYER WHILE SPRAYING TO PREVENT SETTLING.

**GRASS LAWNS** — For the control of Helminthosporium leaf spot and Melting out, Curvularia leaf spot, Dollar spot, Brown patch, Gray leaf spot, Stem rust of bluegrass, Copper spot and Pink snow mold. Also for Alternaria leaf spot in Dichondra lawns. For best results water the day before treatment, then withhold water for 24 hours. Apply as a thorough spray at the rate of 4 fl. oz. (8tbs.) in 4 gallons of water per 125 sq. ft. (1 Pint in 15 gallons of water per 500 sq. ft.). Repeat application in two weeks. For newly planted lawns to prevent "damping-off" make application about one week after seed starts germinating. For toadstools apply at the rate of 8 fl. oz. in 5 gallons of water per 125 sq. ft.

**ORNAMENTALS** — Apply as a thorough cover spray. Use at the rate of 2 fl. oz. per gallon of water. Use to control Rust and Powdery mildew on Roses, Chrysanthemums, Zinnias, Damping off, and Blossom blight.

Note: Do not use on any species of fern.

### STORAGE AND DISPOSAL

Pesticide wastes are toxic. Improper disposal of excess pesticide, pesticide spray or mixture is a violation of Federal Law.

**Storage:** Store in original container in a cool place. Do not store near or contaminate food or feed. Keep out of reach of children.
