1. Scrape and prewash utensils and glasses whenever possible.
2. Wash with a DuBois detergent.
3. Rinse with clean water.
4. Sanitize in a solution of 100 ppm available chlorine (1.5 ounces per 10 gallons of water or one level tablespoonful in 3½ gallons of water). Immerse all utensils for at least 2 minutes.
5. Place sanitized utensils on a rack to air dry.

Food Plants: For final sanitizing rinsing of food plant equipment and utensils use 100 ppm available chlorine (1.5 ounces per 10 gallons of water). Allow equipment to drain and air dry. Do not allow solution strength to fall below 50 ppm available chlorine as determined by chlorine test papers.
