Hand Sanitizing Efficiency Test

In the presence of 408 ppm hard water (24 grain) CONTROL at 1/4 ounce per gallon (200 ppm quat.) is more than equivalent for sanitizing than 50 ppm available chlorine using NaOCl. (Official A.O.A.C. "Available Chlorine Germicidal Equivalent Concentration" as modified by Section 4.4 (B) of the "Guidelines for Obtaining Authorization of Compounds to be Used in Meat and Poultry Plants" USDA.)

USING

DIRECTIONS:

The hands must be washed and thoroughly rinsed prior to sanitizing. Sanitize by dipping hands into a solution of 1/4 ounce of CONTROL per gallon of water. The hands need not be rinsed with potable water following the use of the compound.

TEST KIT:

Use Kit No. 0720, CONTROL/D-TROL Kit or QT-10 Test Papers.
