DANGER: KEEP OUT OF REACH OF CHILDREN

CORROSIVE: Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Protect eyes and skin when handling. Harmful if swallowed. Avoid contamination of food.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

Rinse empty container thoroughly with water before discarding.

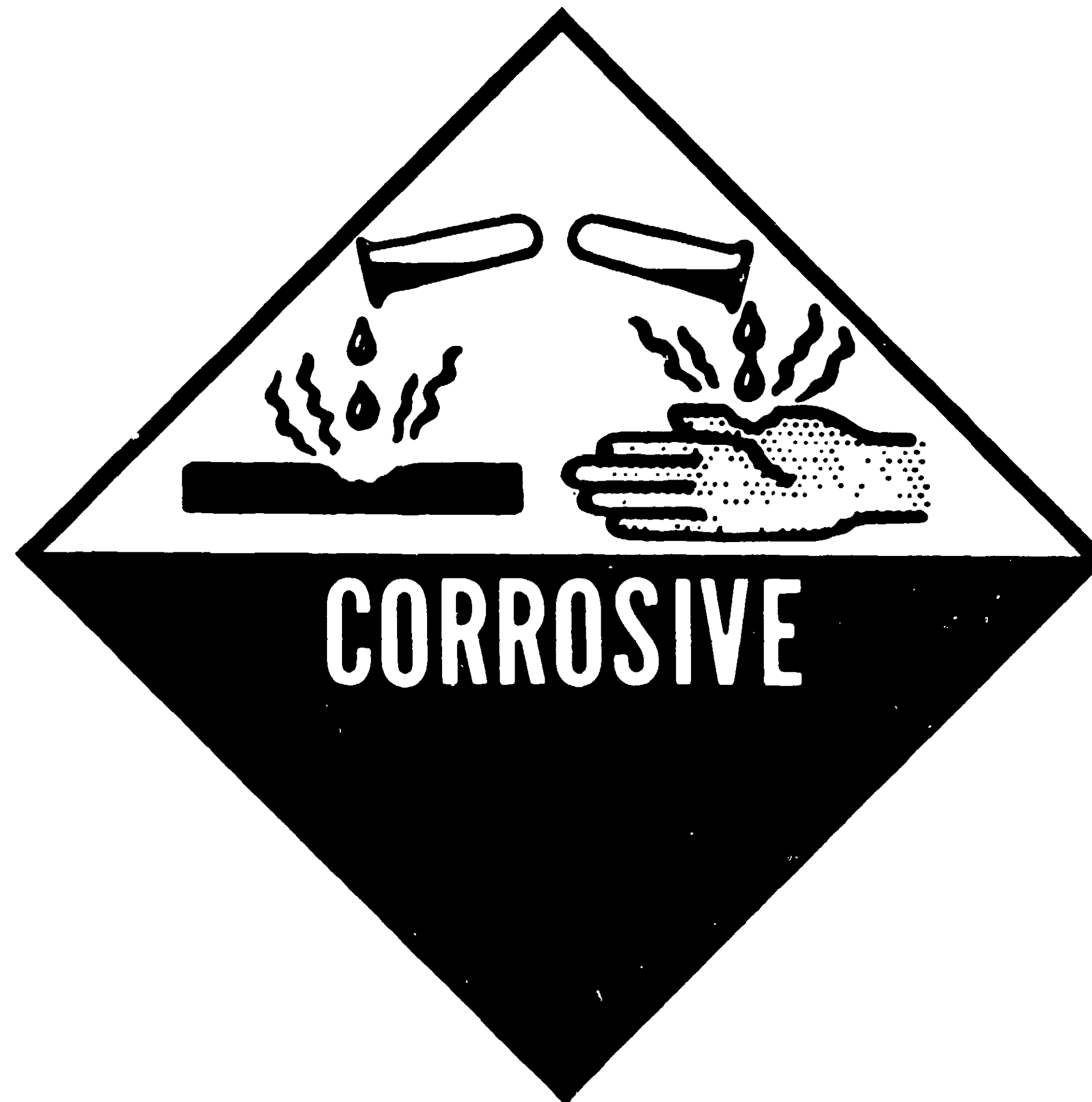
USING INSTRUCTIONS

Wash Room Facilities, Floors and Walls. To disinfect, deodorize and impart a pleasant fresh aroma to restrooms, shower and wash-up facilities, locker rooms, hospital and nursing homes floors and walls, use 2 fluid ounces of QD-4 per gallon in mop water or as a washing solution on hard surfaces. May be followed by a rinse if desired. Excellent for high traffic low maintenance wash rooms such as found in service stations, bus terminals, and sports complexes.

Animal Cages and Veterinarian Operations. Use at 2 fluid ounces per gallon to disinfect and to deodorize and clean cages, tray, racks, walls, floors, etc. Follow with a thorough fresh water rinse, especially where there will be subsequent animal contact. All treated animal food contact surfaces must be rinsed with potable water after treatment.

Deodorizing & Reodorizing. Use at 1 to 3 fluid ounces per gallon. See QD-4 Technical Data Sheet for suggested use areas.
