This product kills bugs and insects quickly on contact, and leaves an invisible film of residual action that keeps on killing for weeks. **DIRECTIONS:** This product is designed for spot treatment only indoors in homes, stores, offices, warehouses, restaurants, etc., and for certain outdoor use. Do not use as a space spray.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and other localized areas infested with insects. Spray window sills and door frames where ants enter. Repeat treatment as required.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpet where insects may be found. Treat crevices, cracks, and infested areas of shelving in closets. Repeat as necessary.

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Do not use as a space spray; instead use HOT SHOT FLY AND MOSQUITO INSECT KILLER for space spraying.

FLEAS, CHIGGERS, ANTS AND BROWN DOG TICKS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas, spray into weeds, bushes and non-crop areas around the home. Spray infested area thoroughly. For ants, thoroughly wet hills and runways. Repeat application as reinfestations appear.

CAUTION: Keep out of reach of children. Harmful if swallowed. If swallowed, get medical attention. Atropine is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine. Avoid contamination of food or food utensils. Avoid inhalation and skin contact; wash thoroughly after using. Do not use on household pets and humans. Do not use in edible products areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Do not use as a space spray. Do not spray heavily on linoleum, asphalt tile, and siding, or plastics. Do not re-use container. Destroy when empty.
